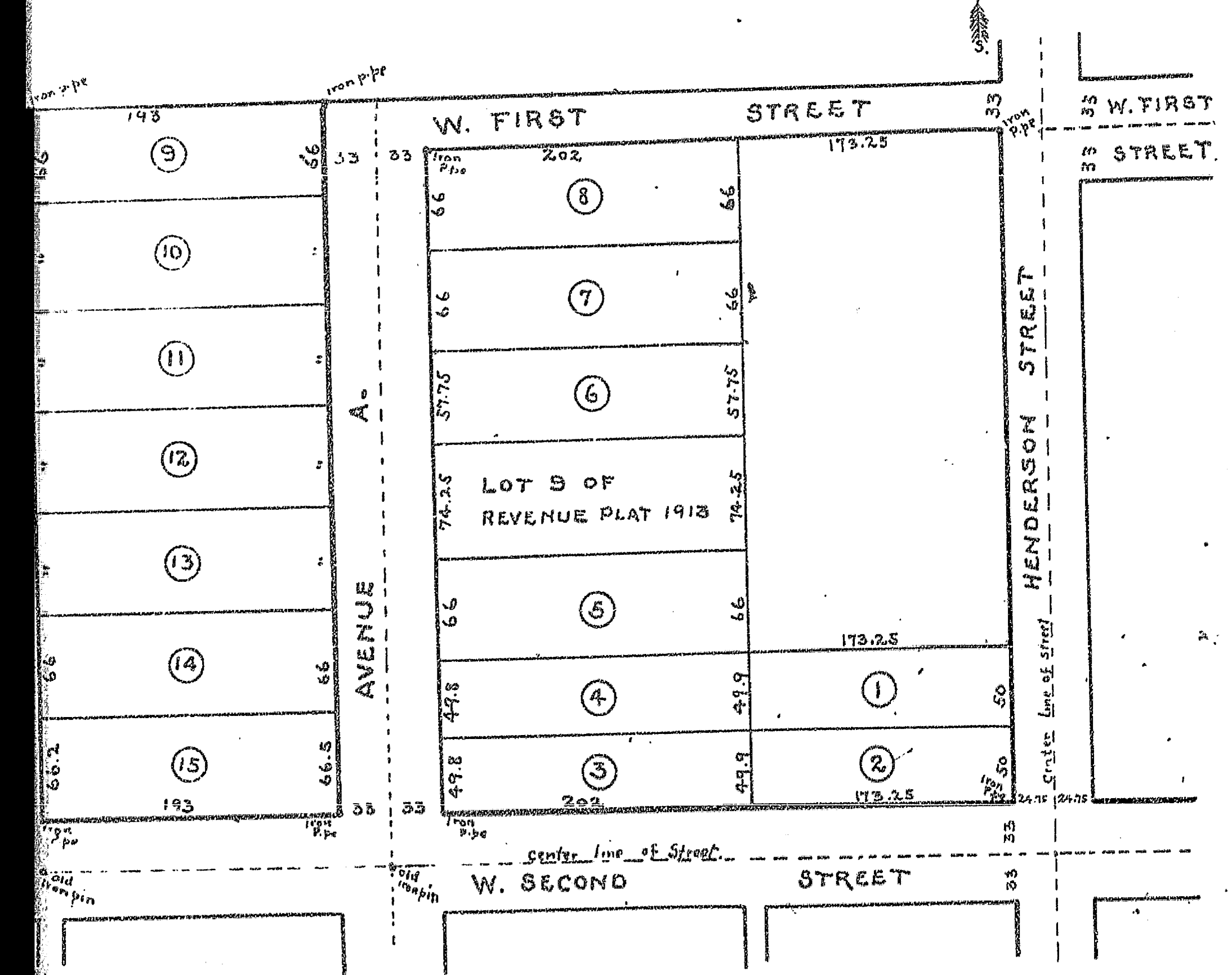
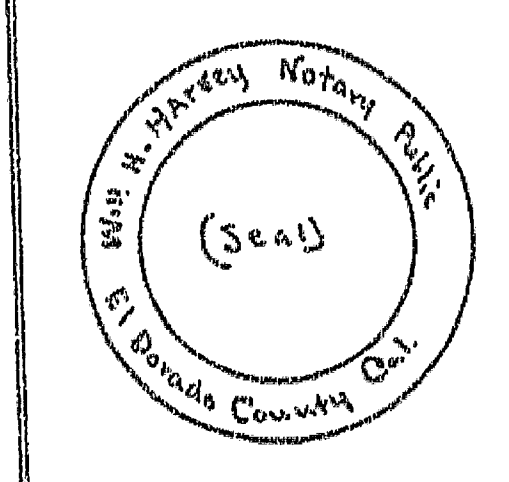


PLAT OF

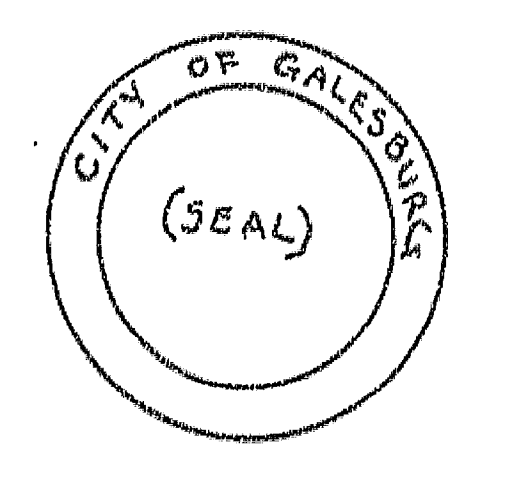

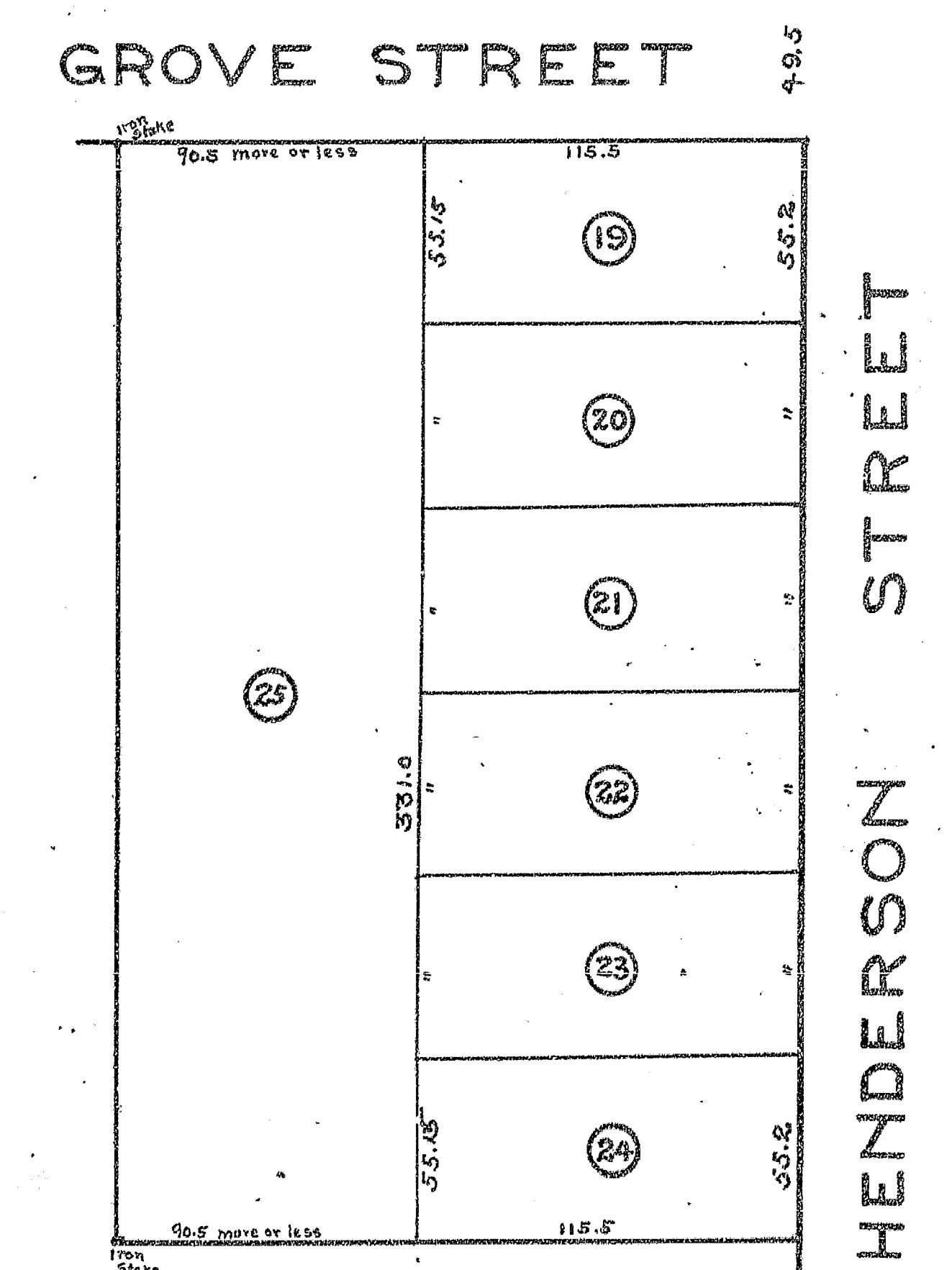
