

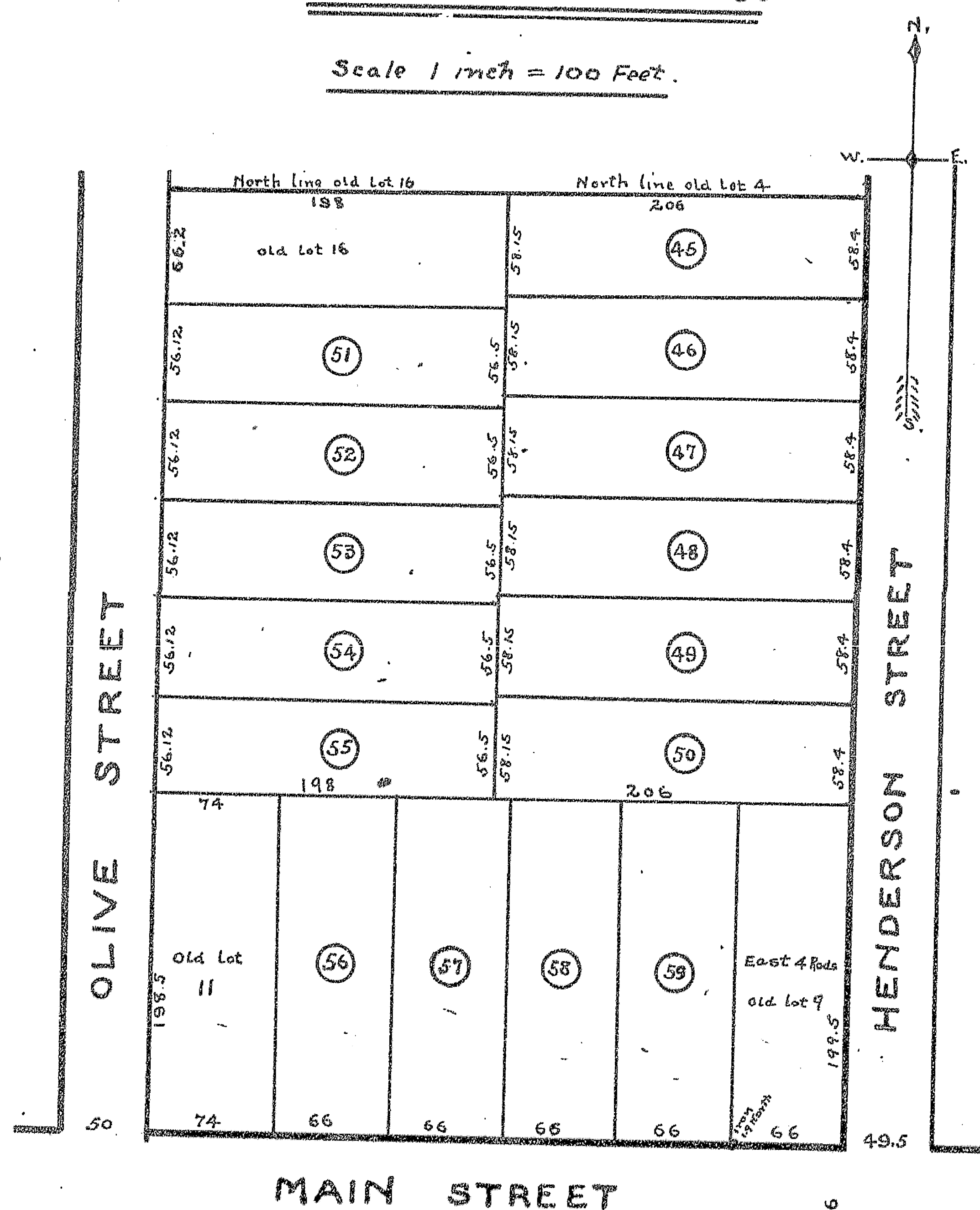

HATHAWAY'S SUBDIVISION

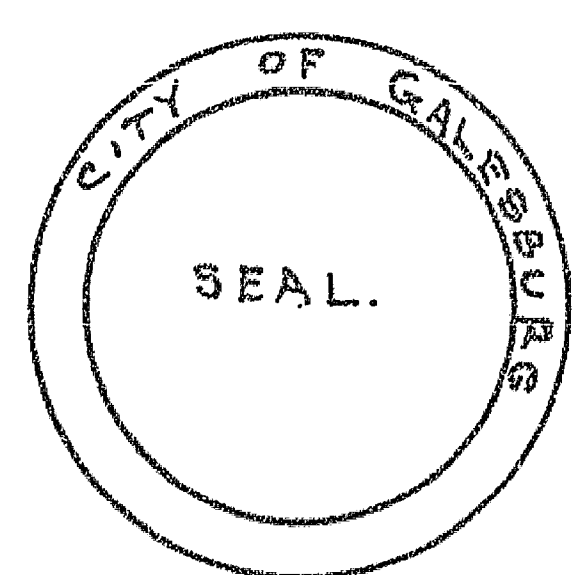

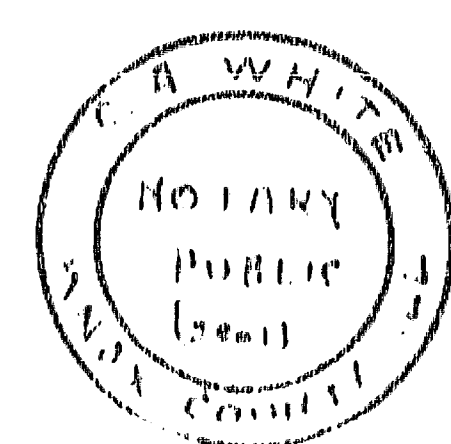

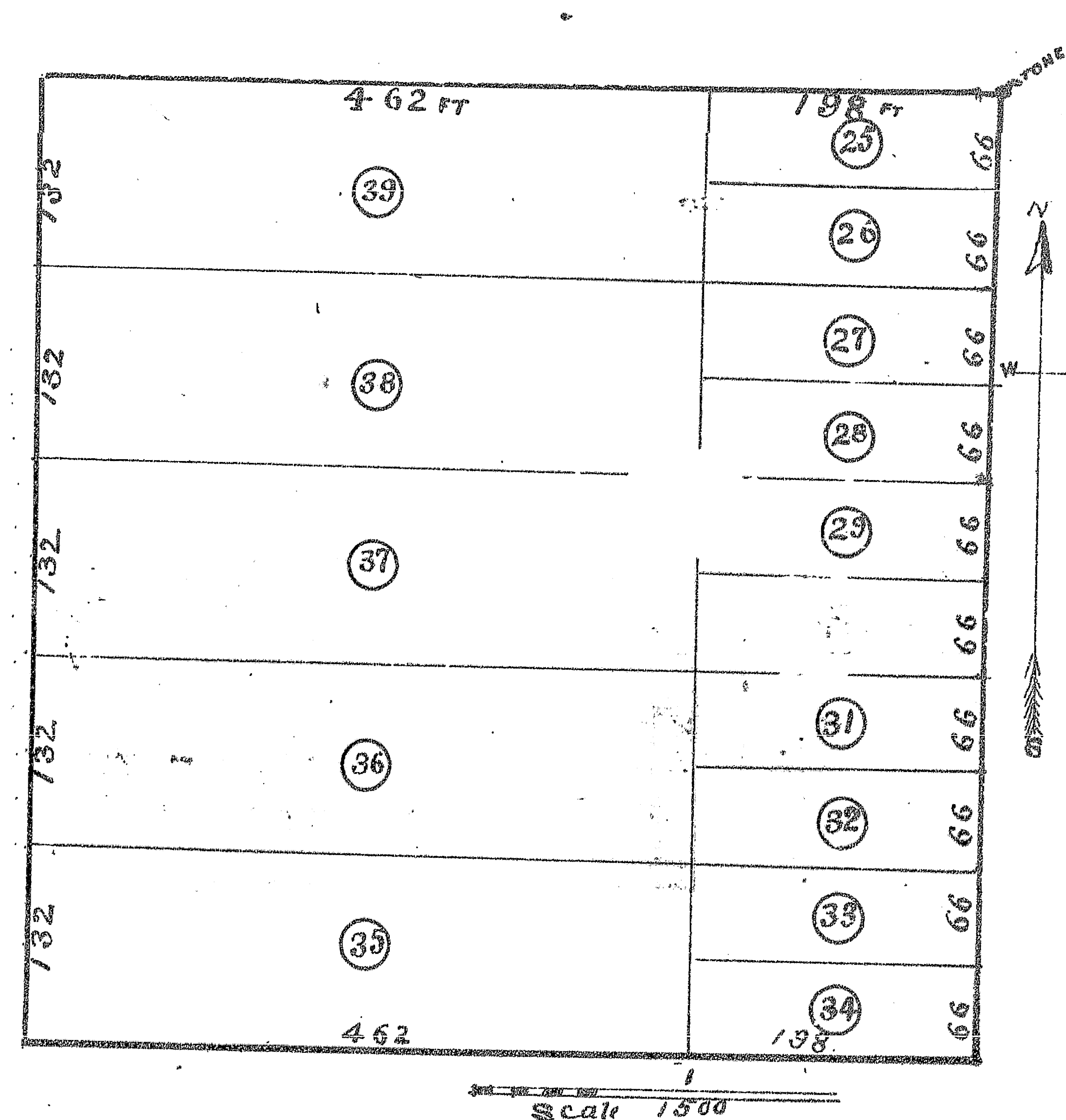
