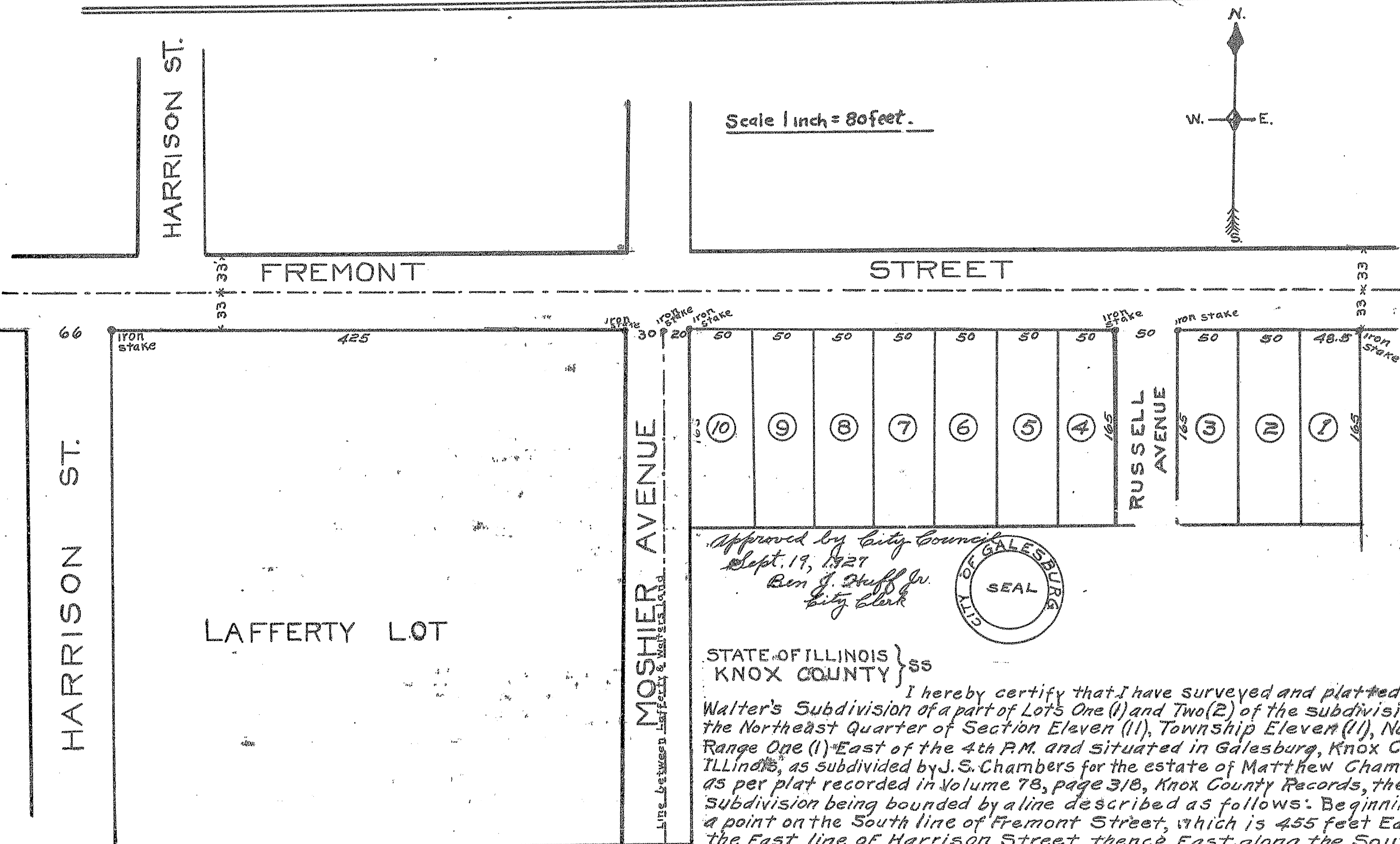


# C. H. WALTER'S SUBDIVISION

 I hereby certify that I have surveyed and platted C.H. Walter's Subdivision of a part of Lots One (1) and Two (2) of the subdivision of the Northeast Quarter of Section Eleven (11), Township Eleven (11), North Range One (1) East of the 4th P.M. and situated in Galesburg, Knox County, Illinois, as subdivided by J.S. Chambers for the estate of Matthew Chambers, as per plat recorded in Volume 78, page 318, Knox County Records, the said Subdivision being bounded by a line described as follows: Beginning at a point on the South line of Fremont Street, which is 455 feet East of the East line of Harrison Street, thence East, along the South line of Fremont Street 569 feet, thence South 165 feet, thence West 569 feet, thence North 165 feet to the place of beginning, also including the land occupied by the new street designated as Mosier Avenue on the said annexed plat, which truly represents the said Subdivision as made by me.
