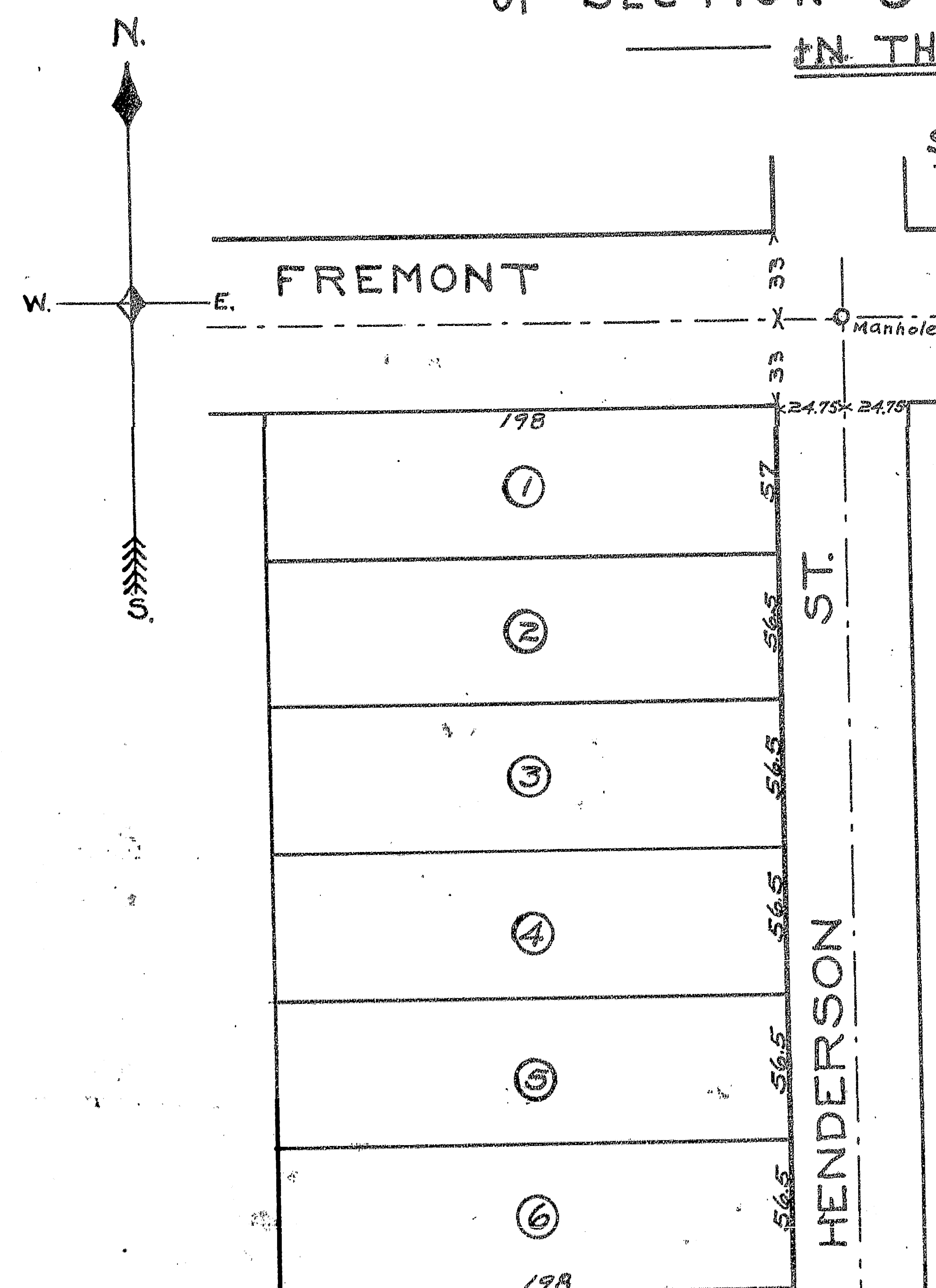


PLAT OF

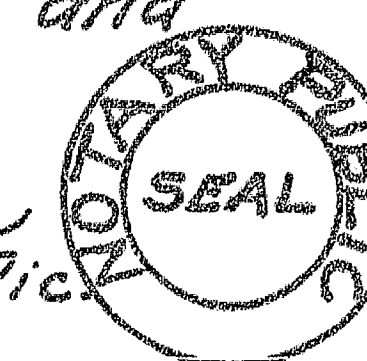

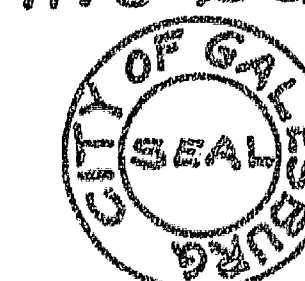
