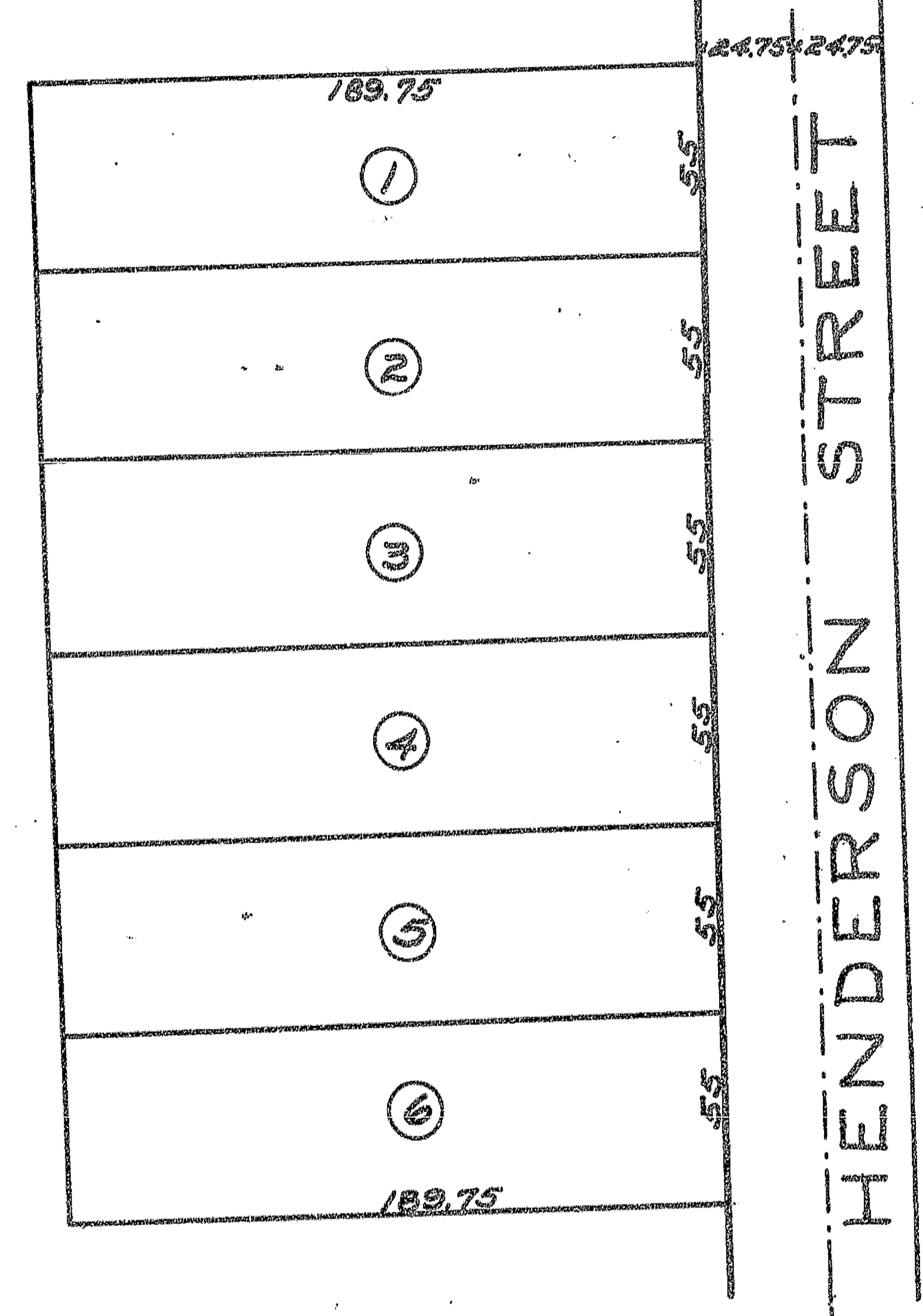
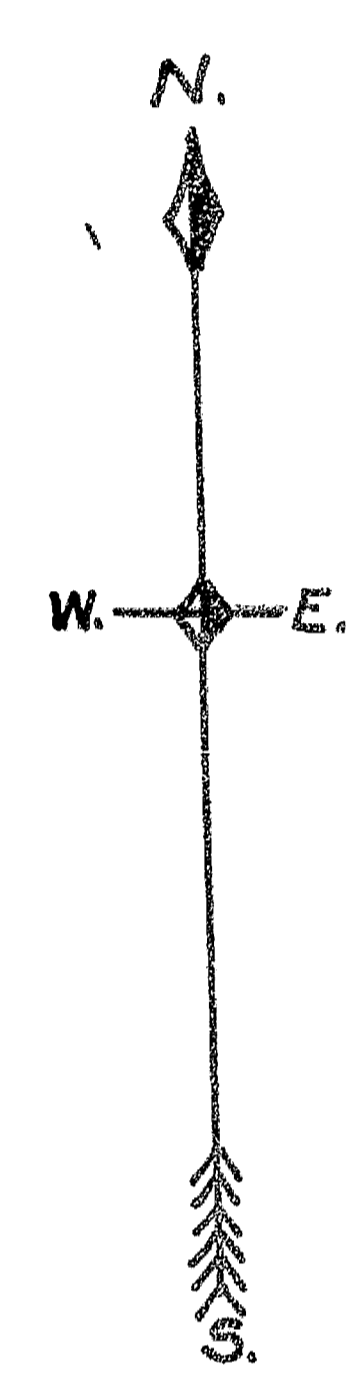


PLAT OF

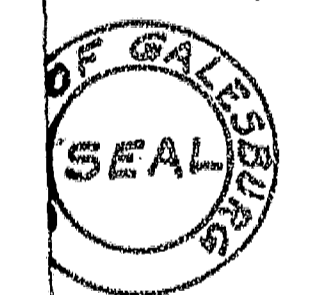

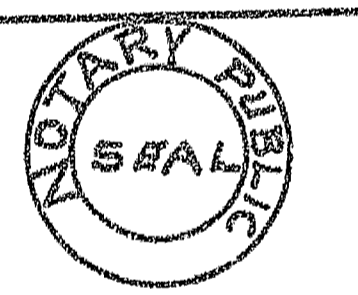

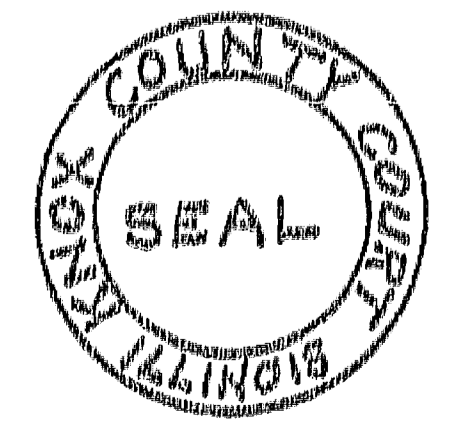
