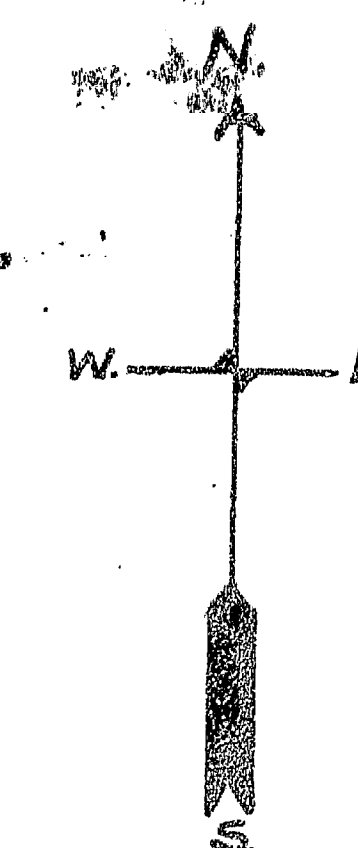


PANKEY'S SUBDIVISION

CITY OF GALESBURG, KNOX COUNTY, ILLINOIS.



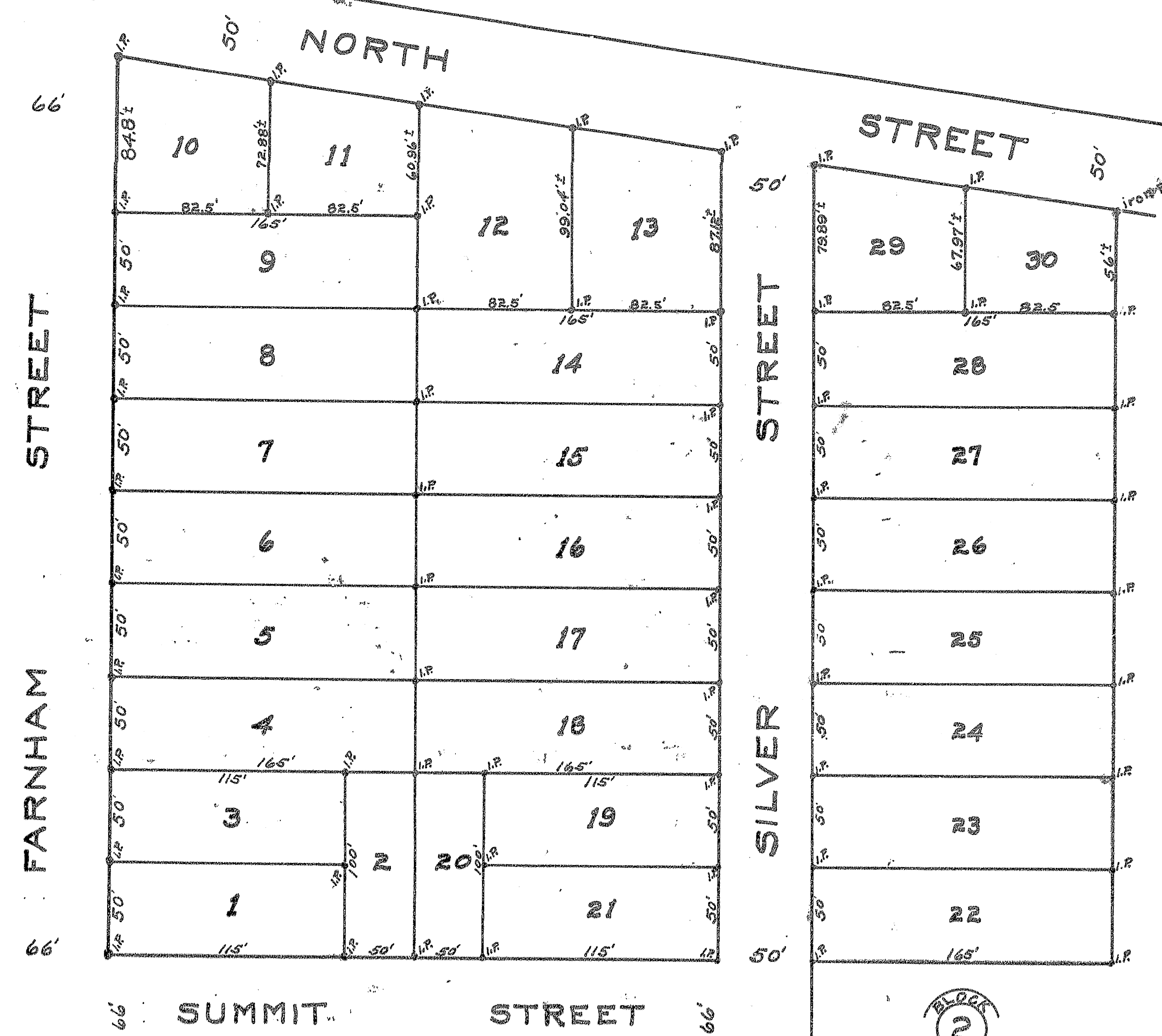

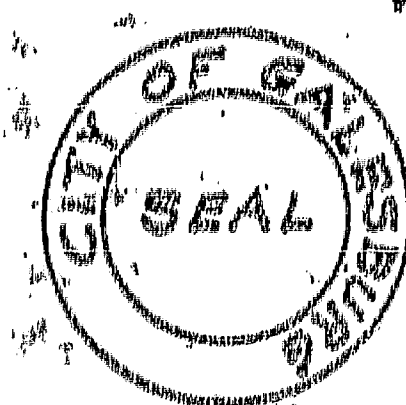
