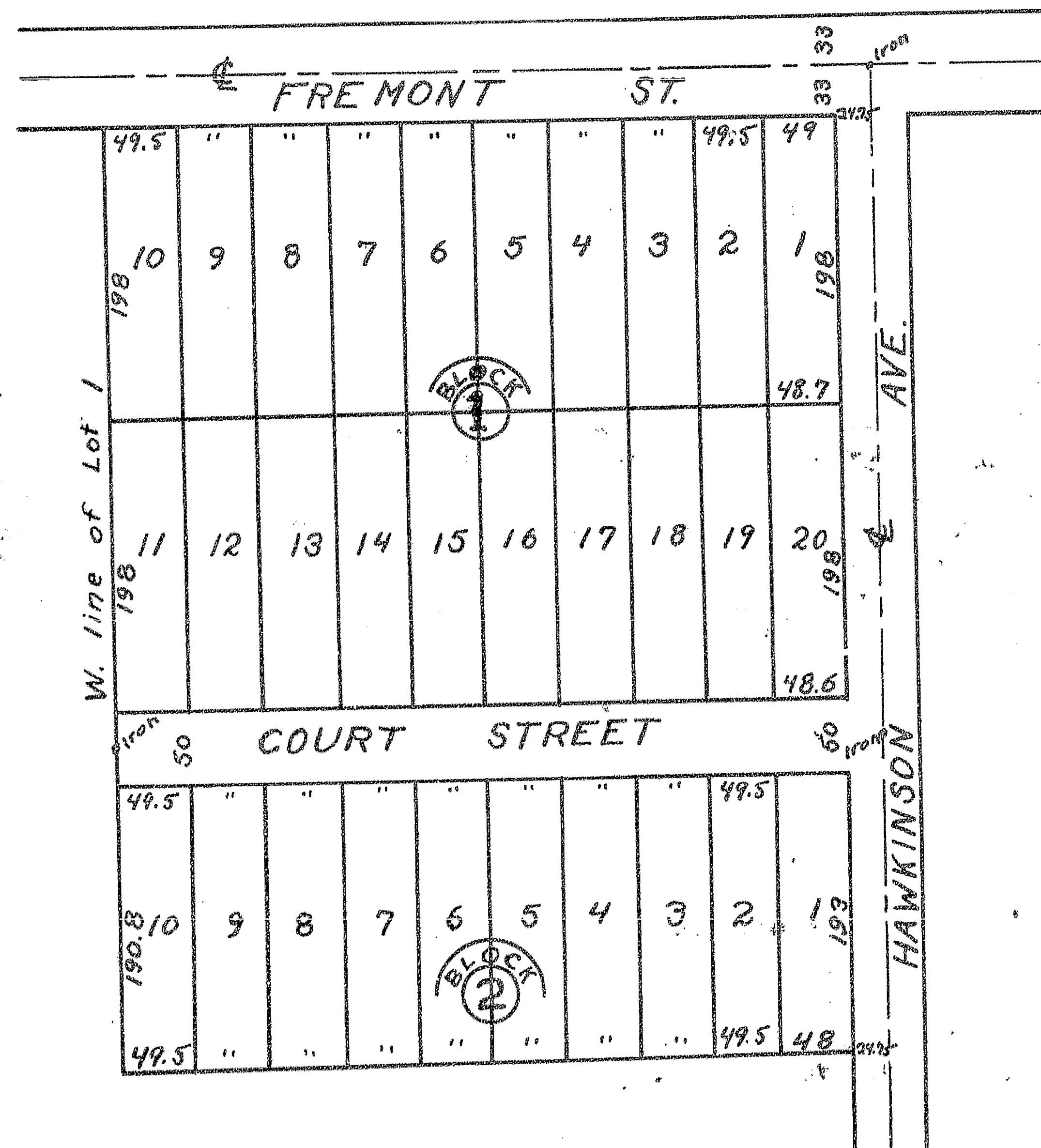


— PLAT OF —

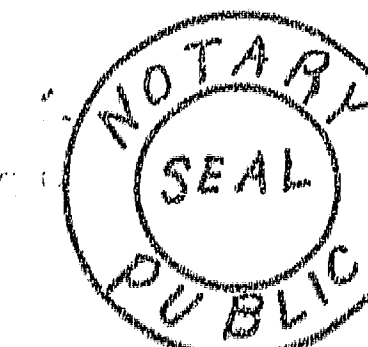
