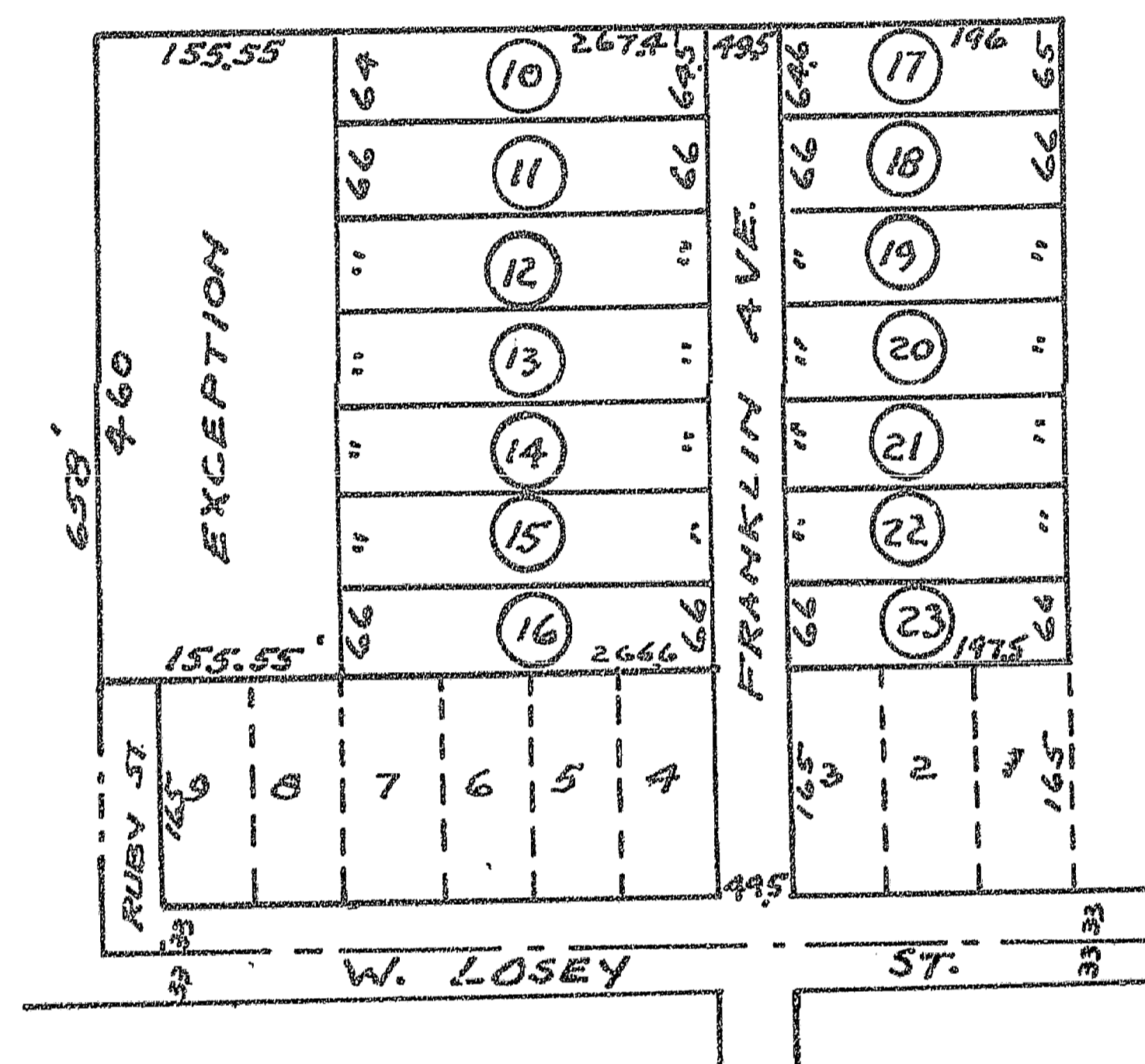

# JOHN A NELSON'S RESUBDIVISION



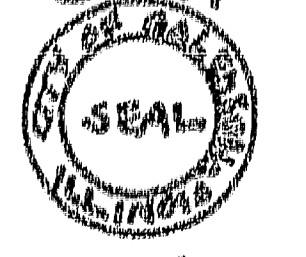
