

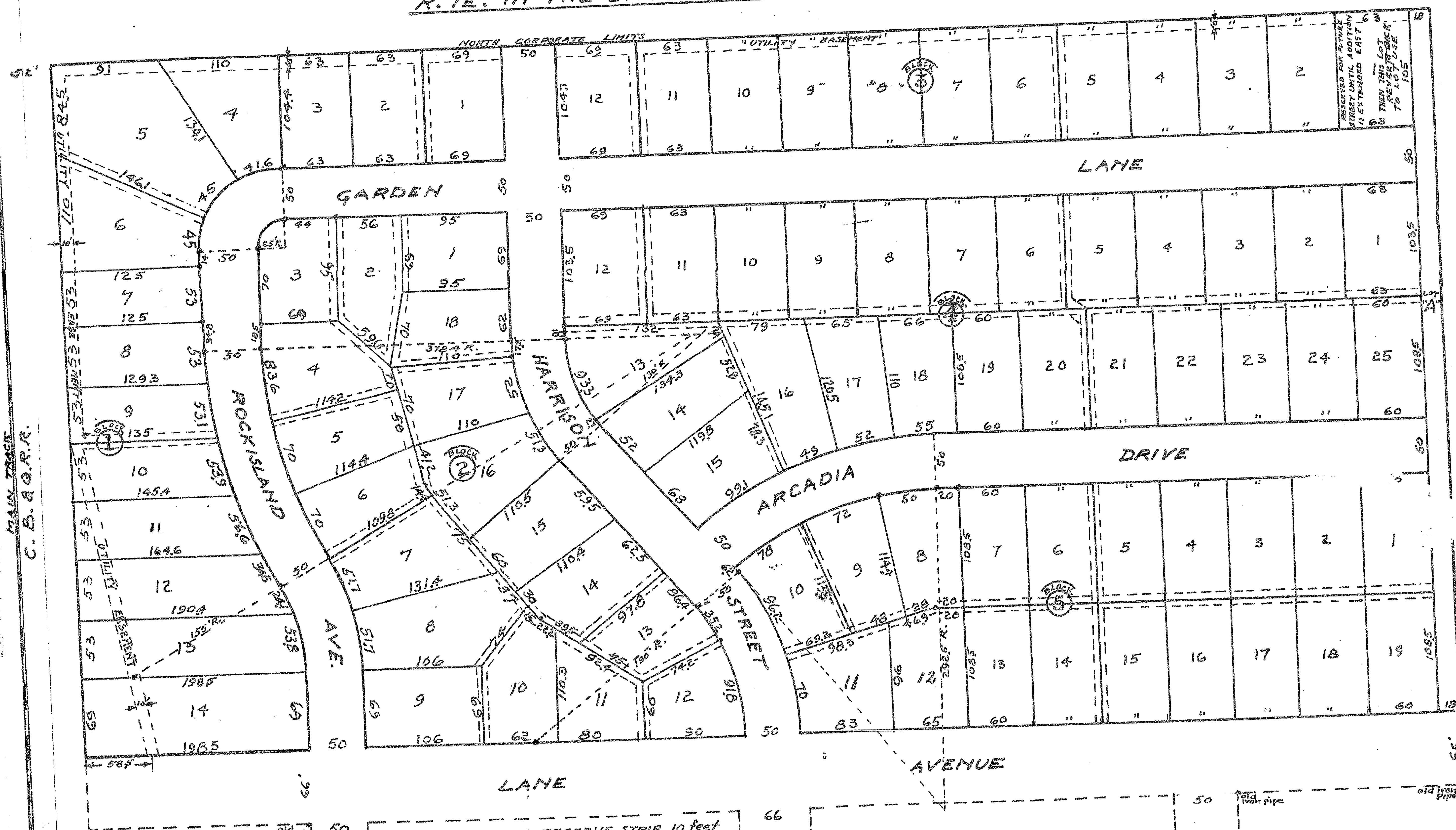

R. 1E. IN THE CITY OF GALESBURG, KNOX COUNTY, ILLINOIS.

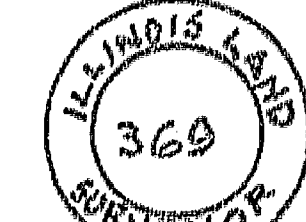

sides of Addition shown.

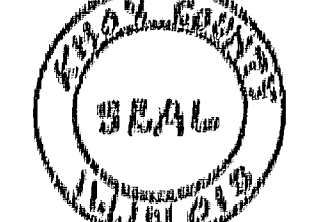
