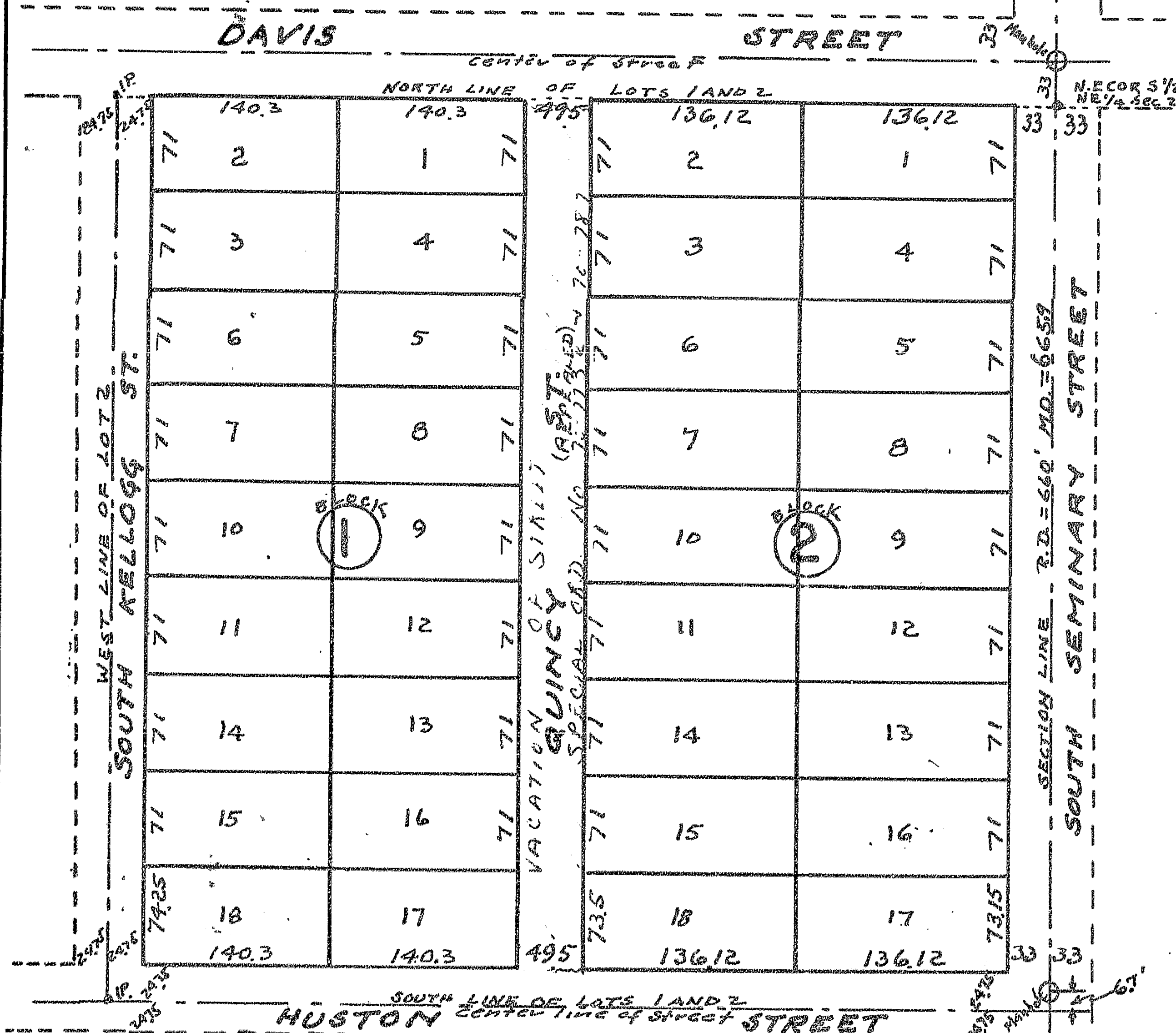


PLAT OF THE GUENTHER SUBDIVISION
