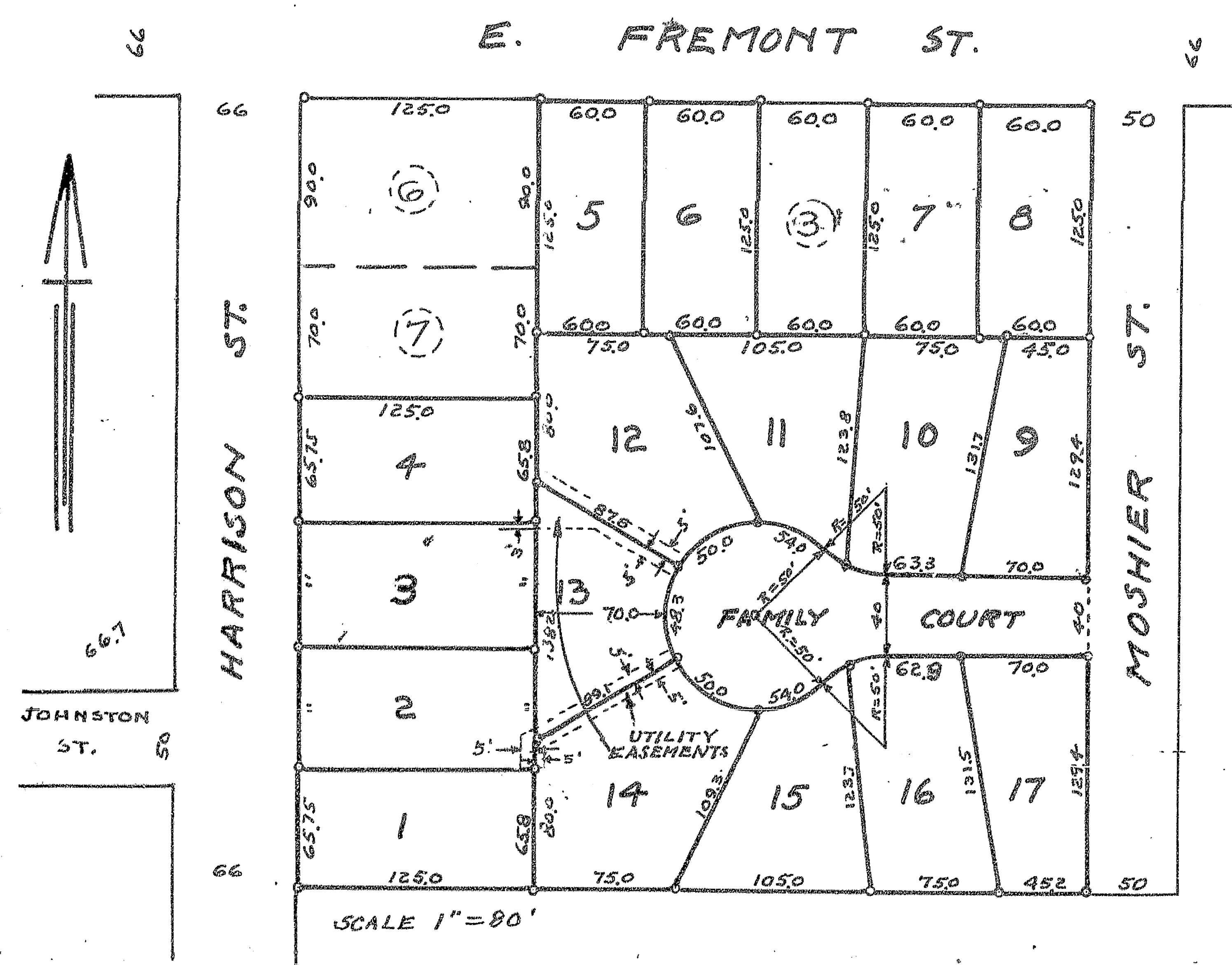


PLAT OF WEBER'S RESUBDIVISION

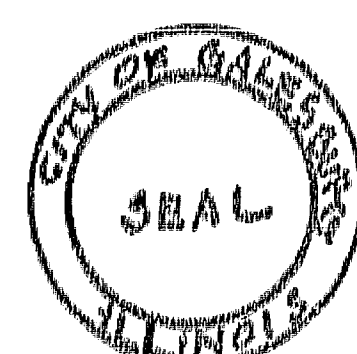
