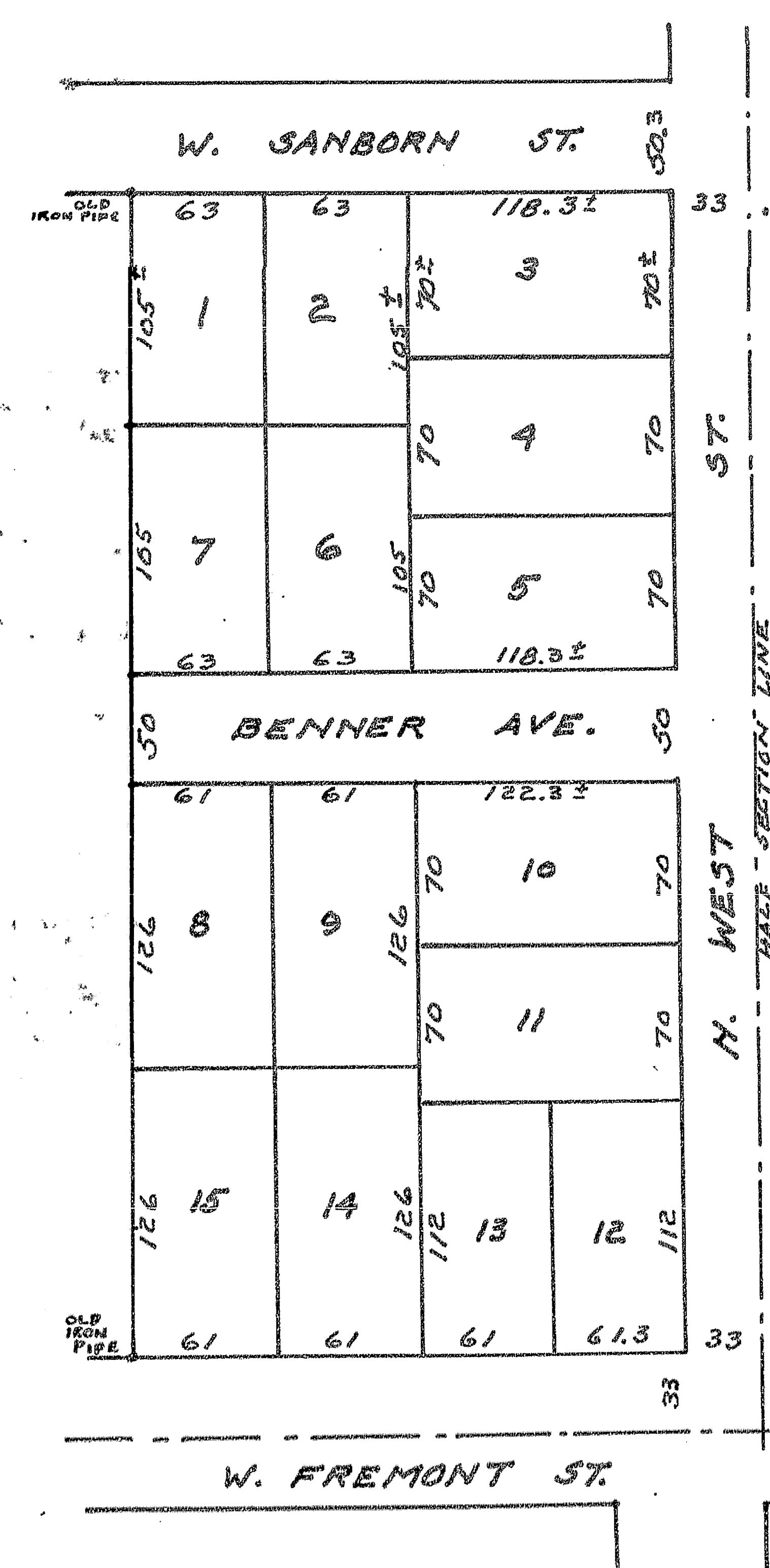


PLAT OF THE BENNER SUBDIVISION

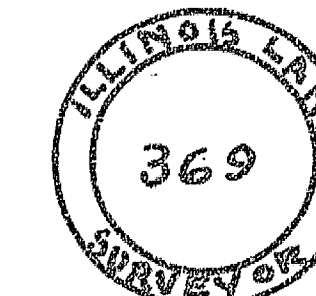

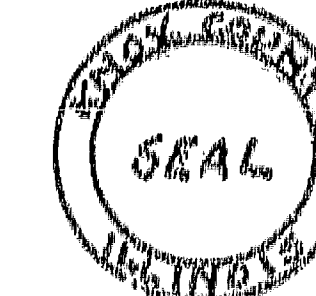
