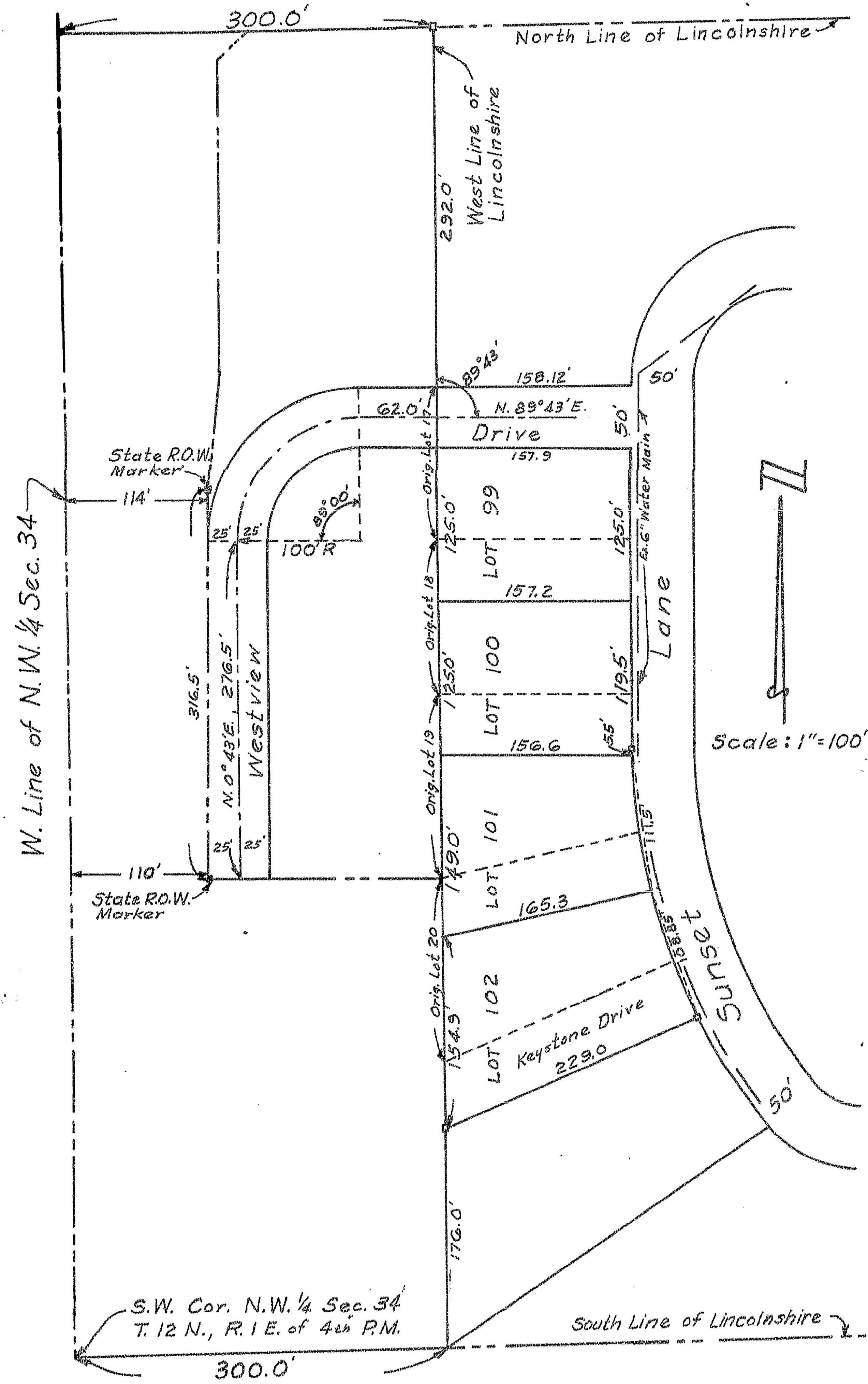


PLAT OF A RESUBDIVISION
