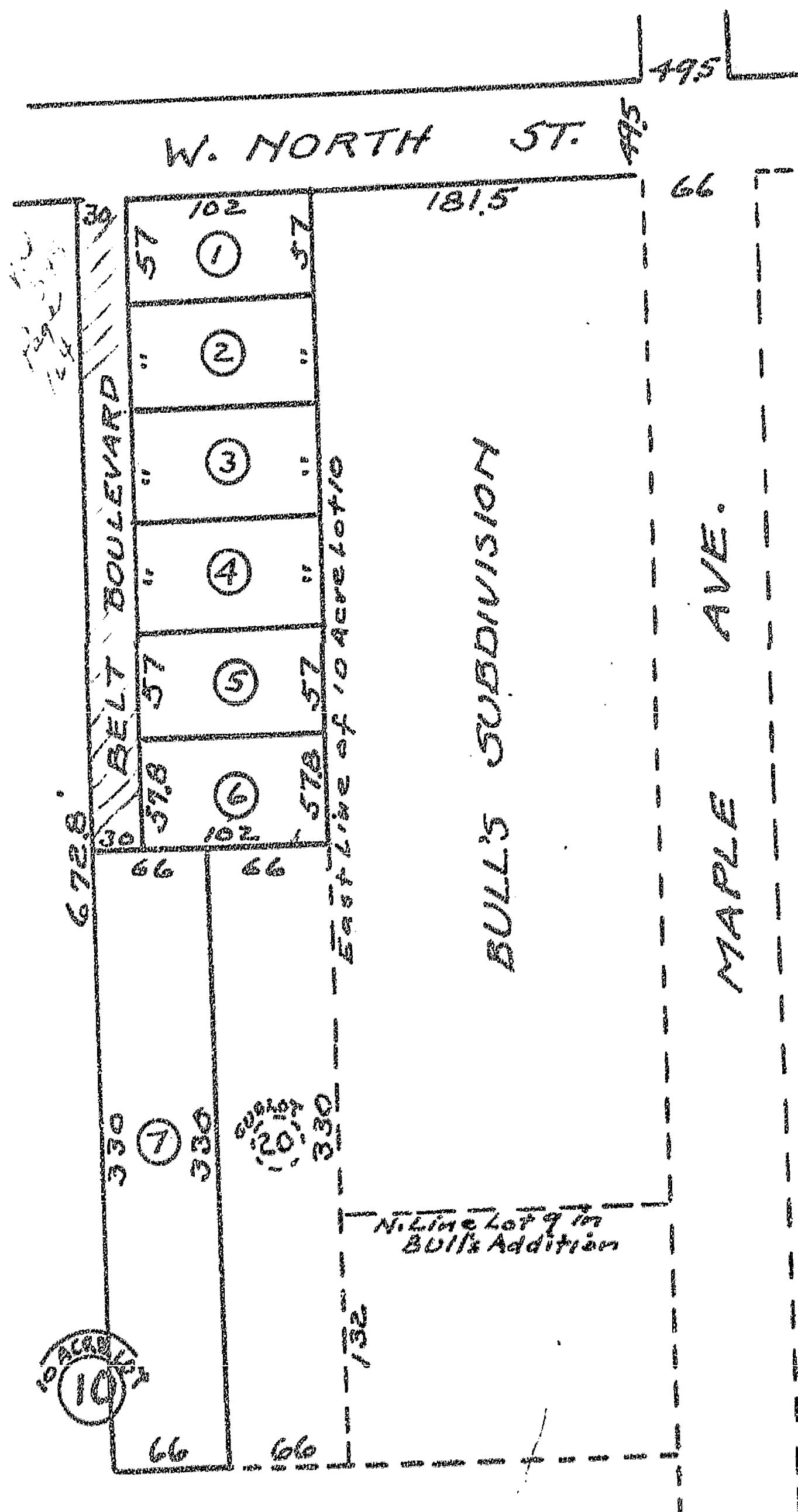


PLAT OF A RESUBDIVISION OF

KNOX COUNTY ILLINOIS

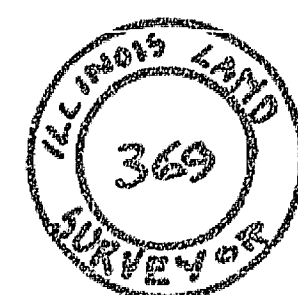

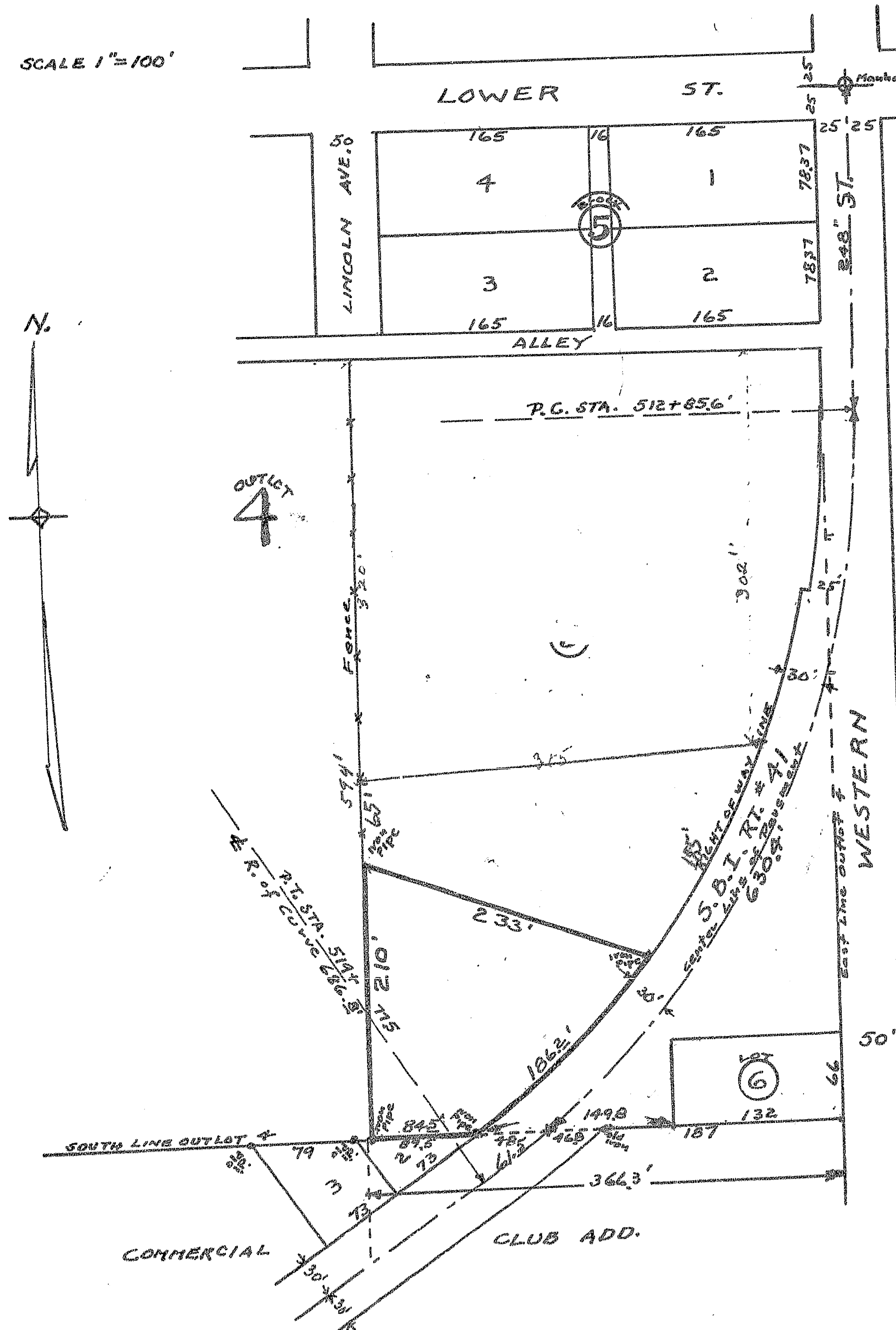
