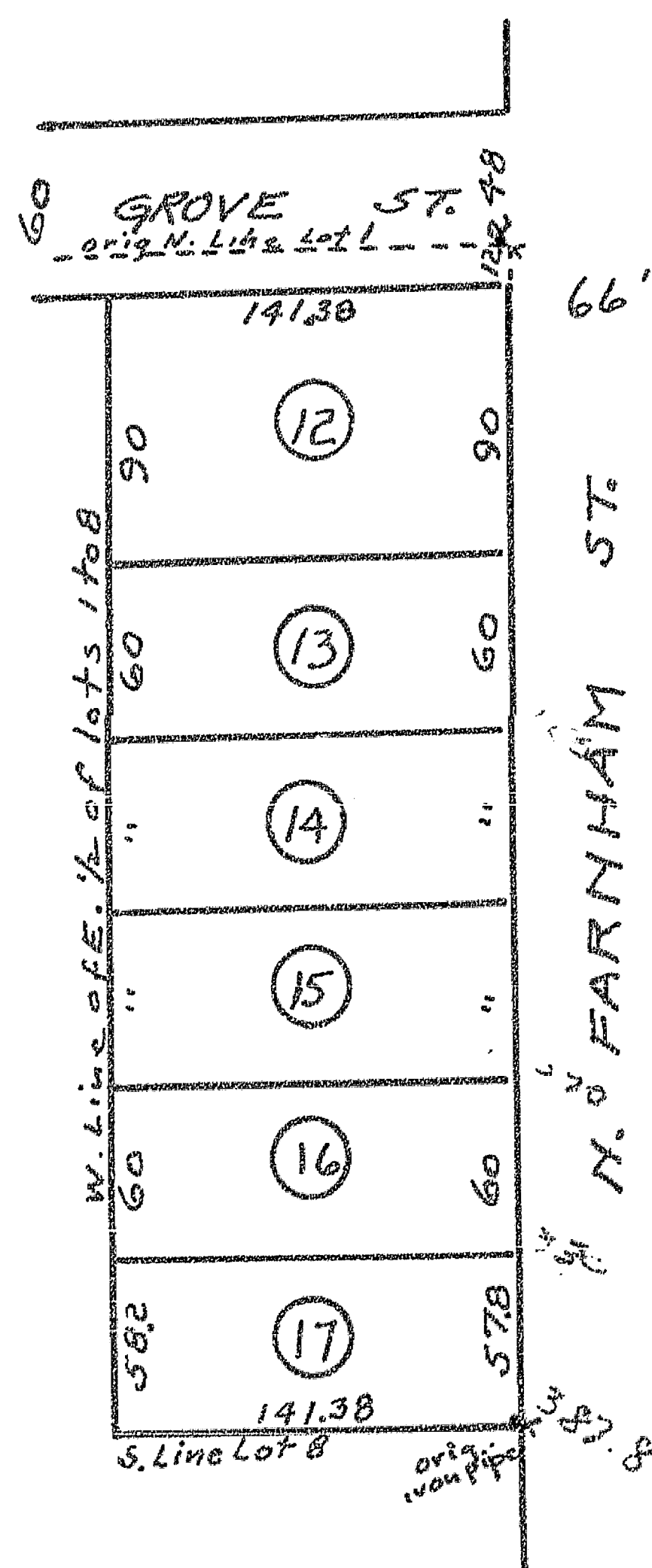


PLAT OF

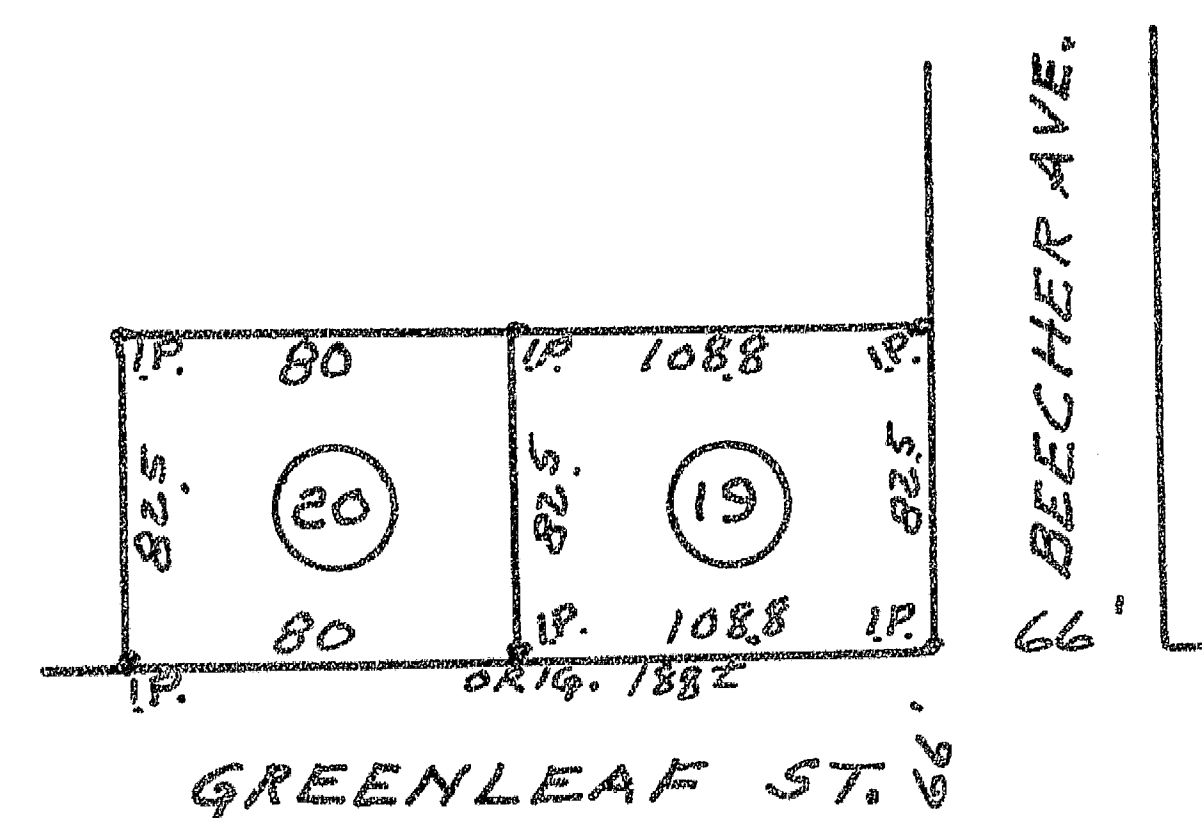
