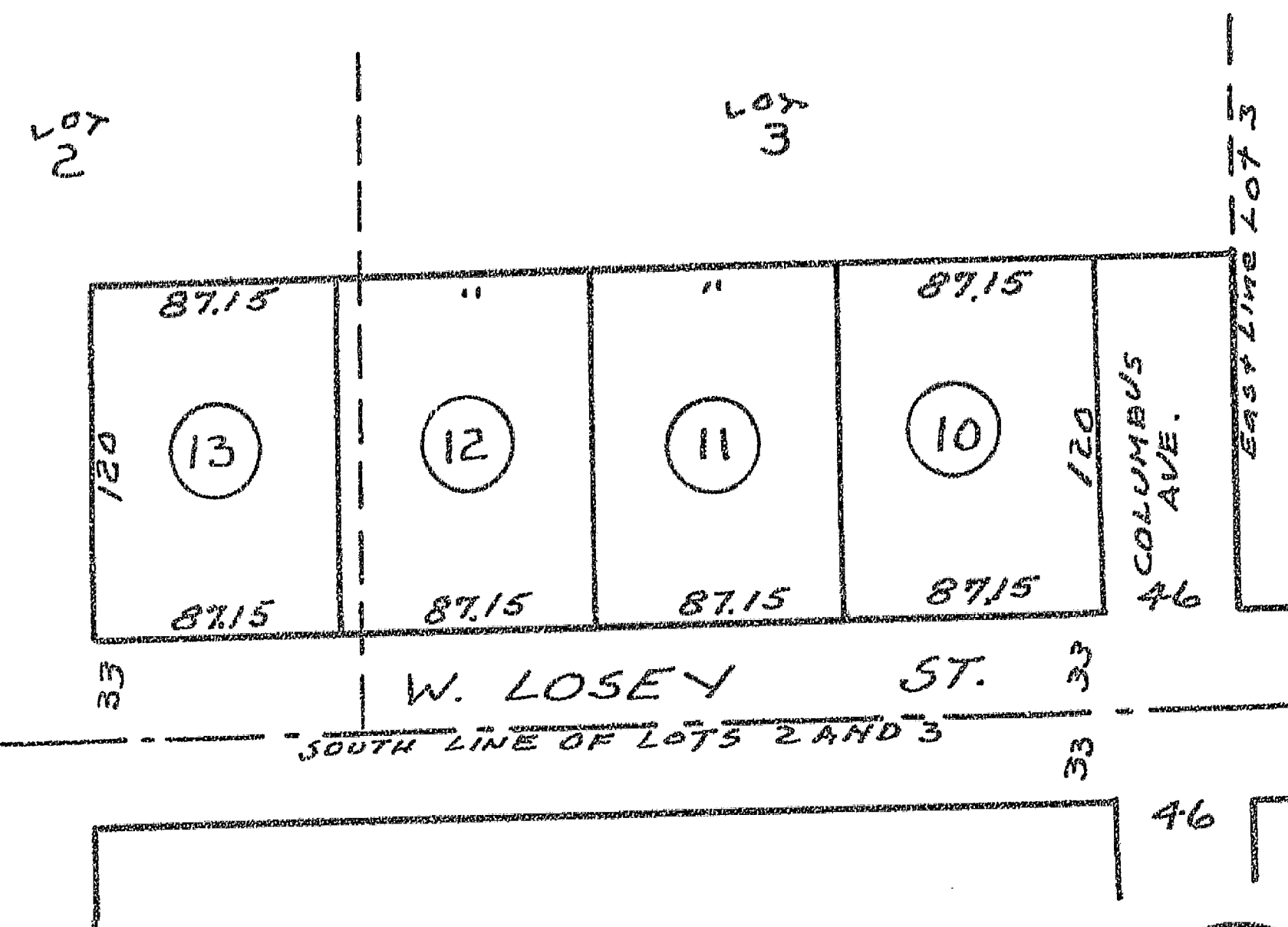


PLAT OF THE ARMSTRONG SUBDIVISION

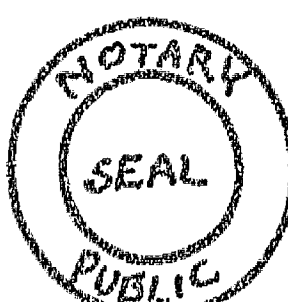

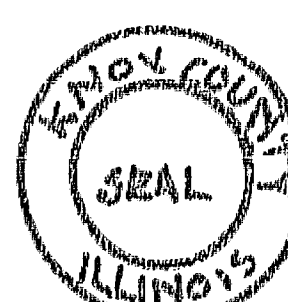

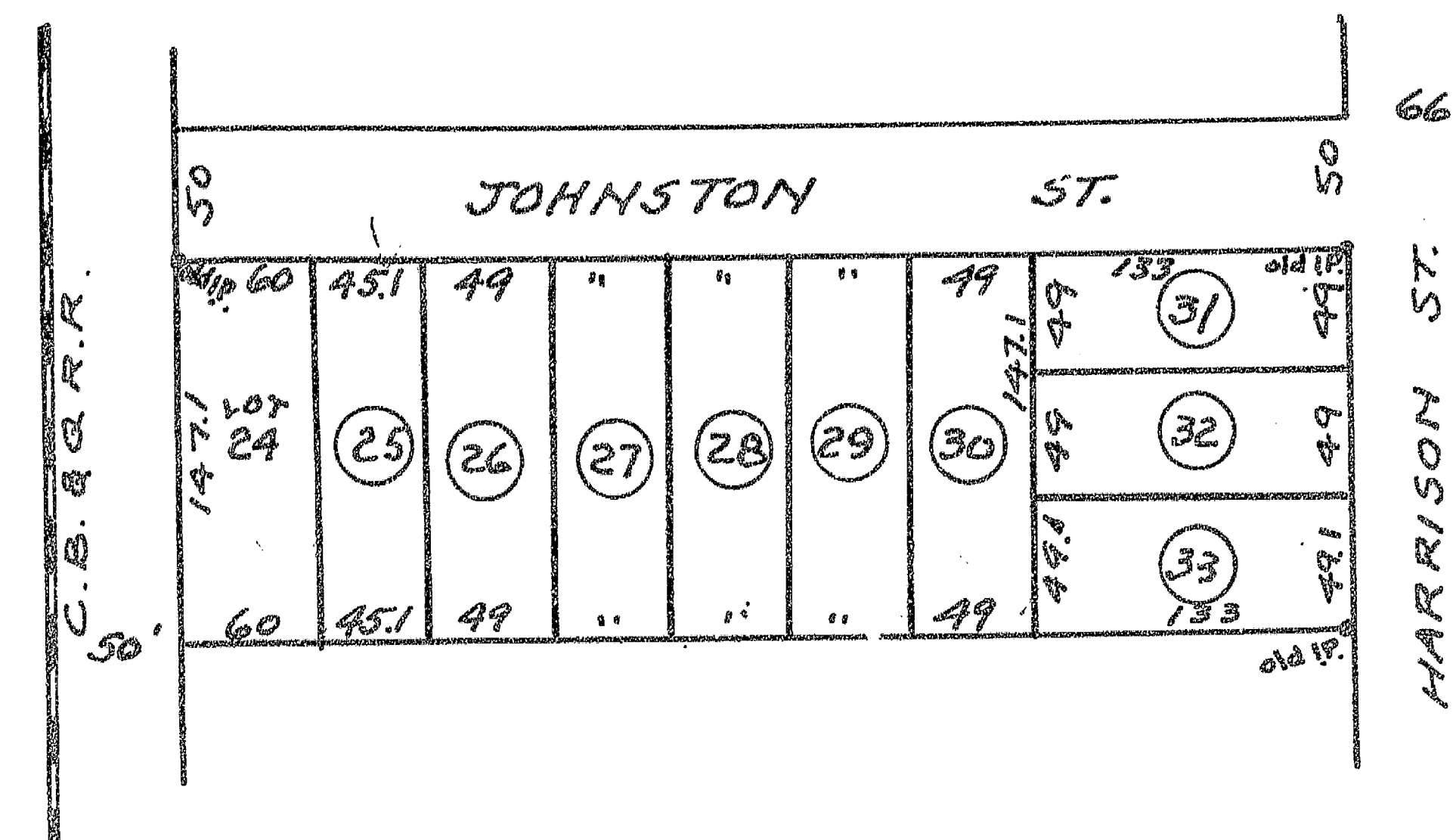

SCALE 1"=120'

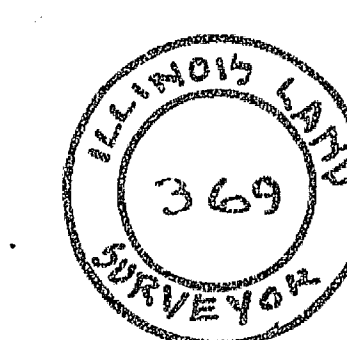

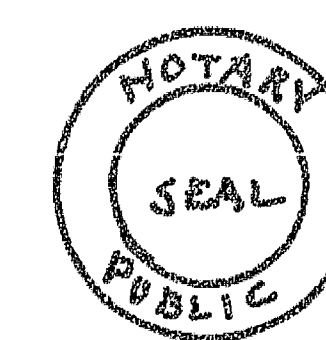

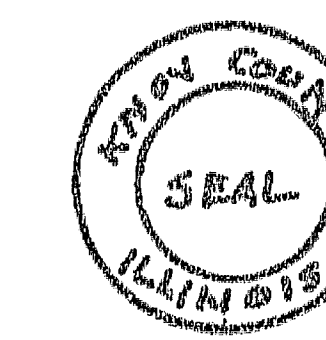
