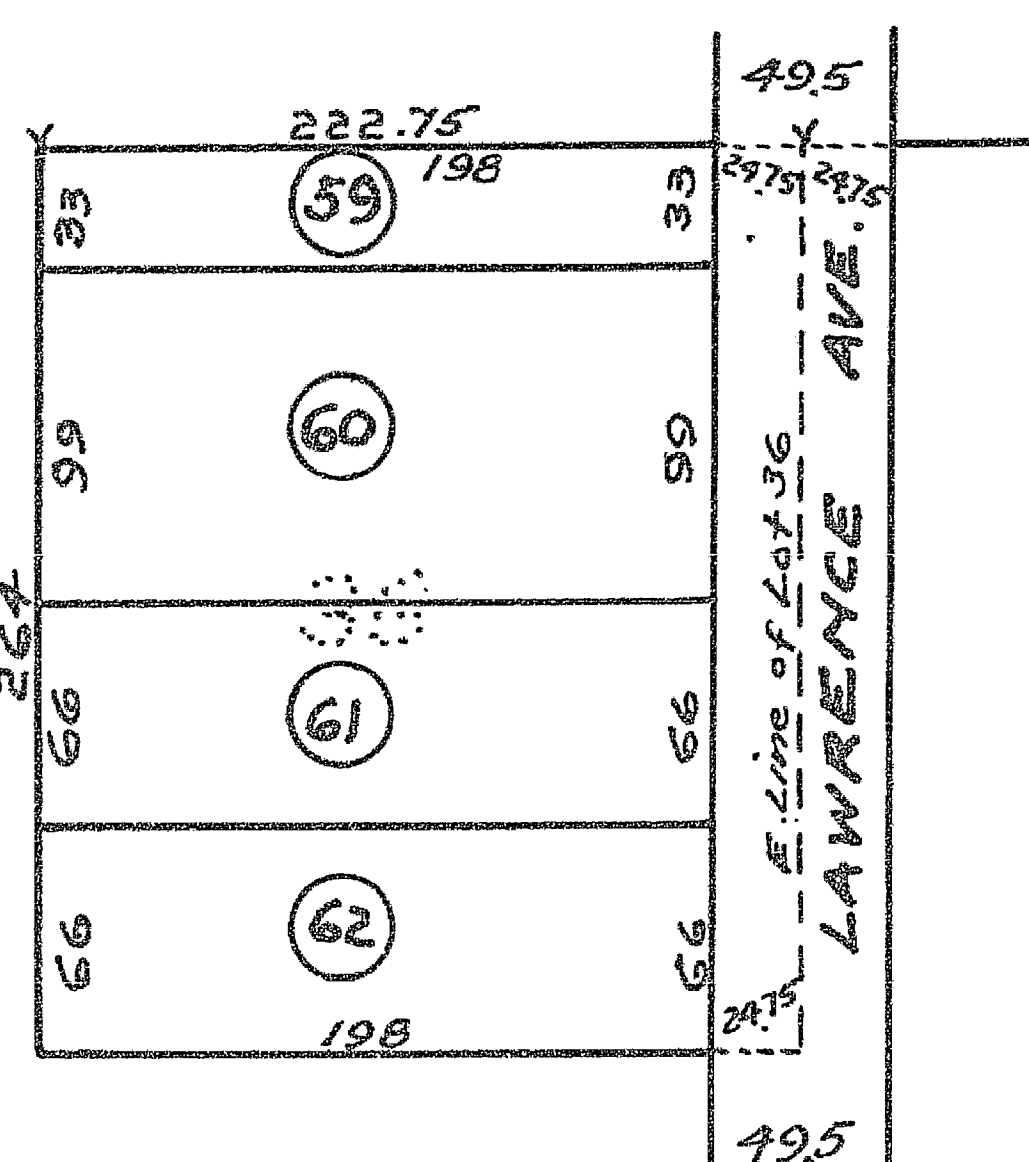


PLAT OF A RESUBDIVISION OF

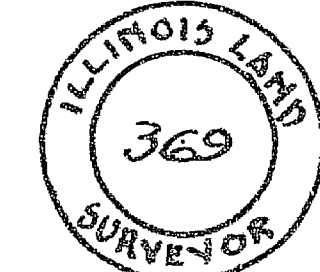

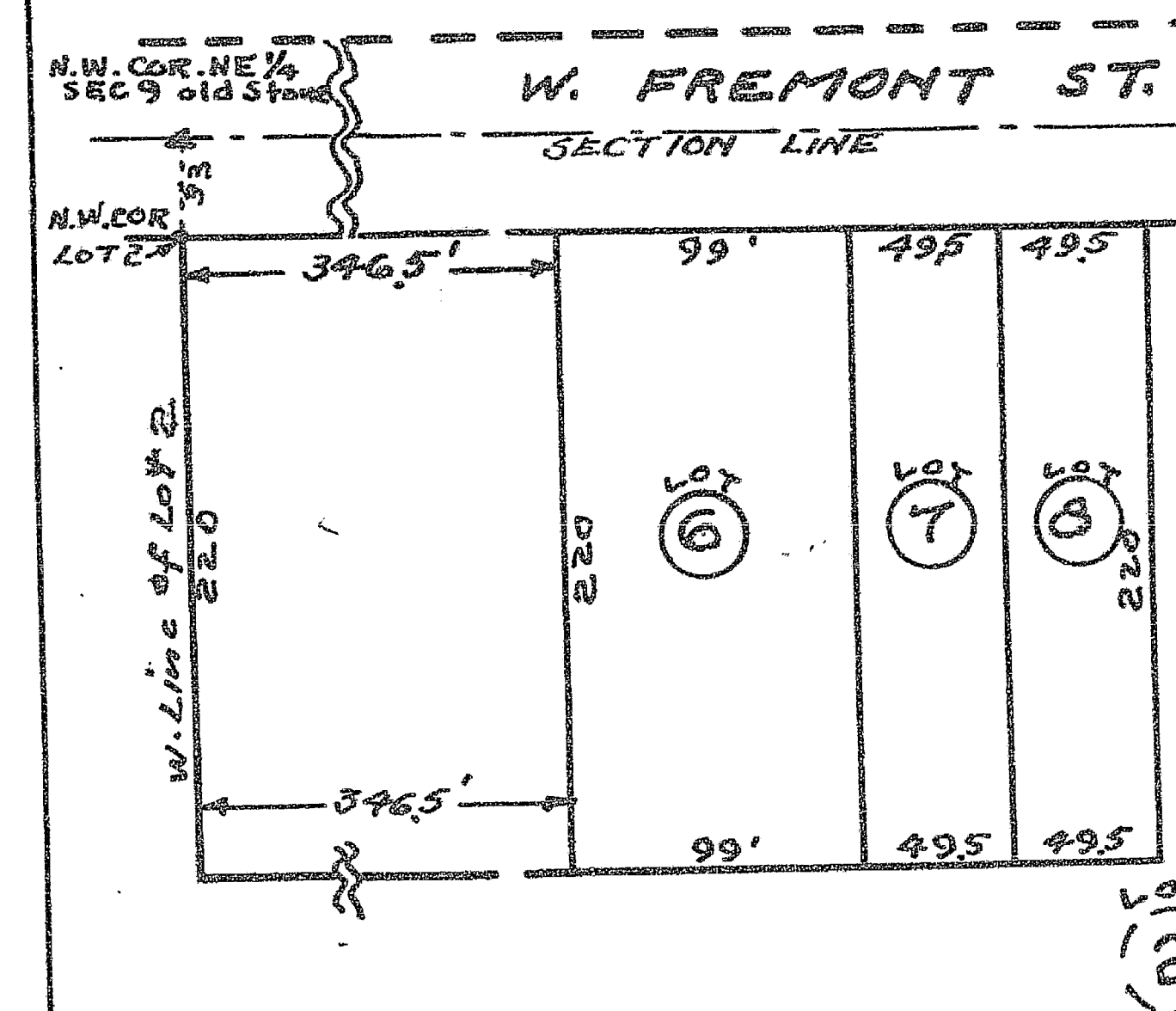

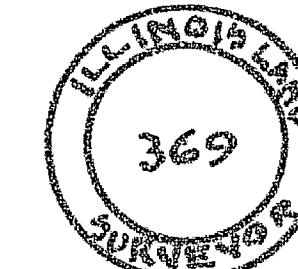
