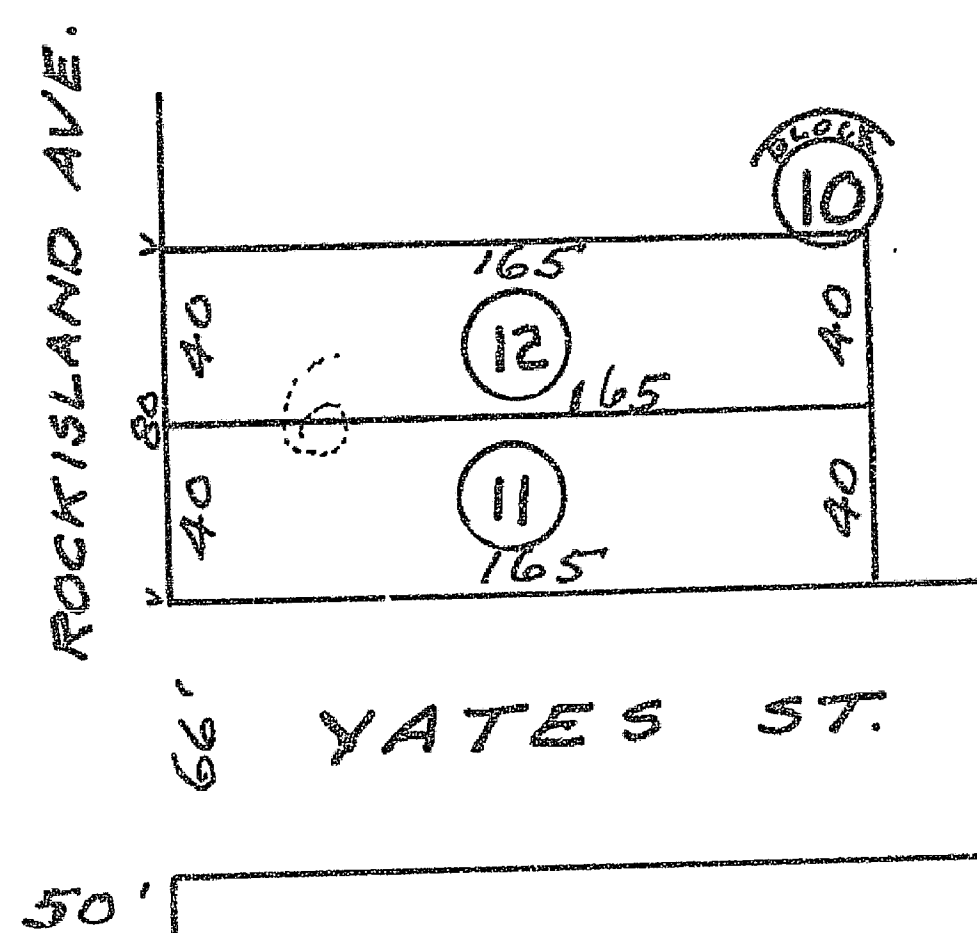


PLAT OF A RESUBDIVISION OF

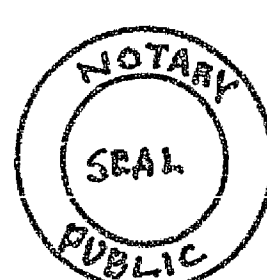

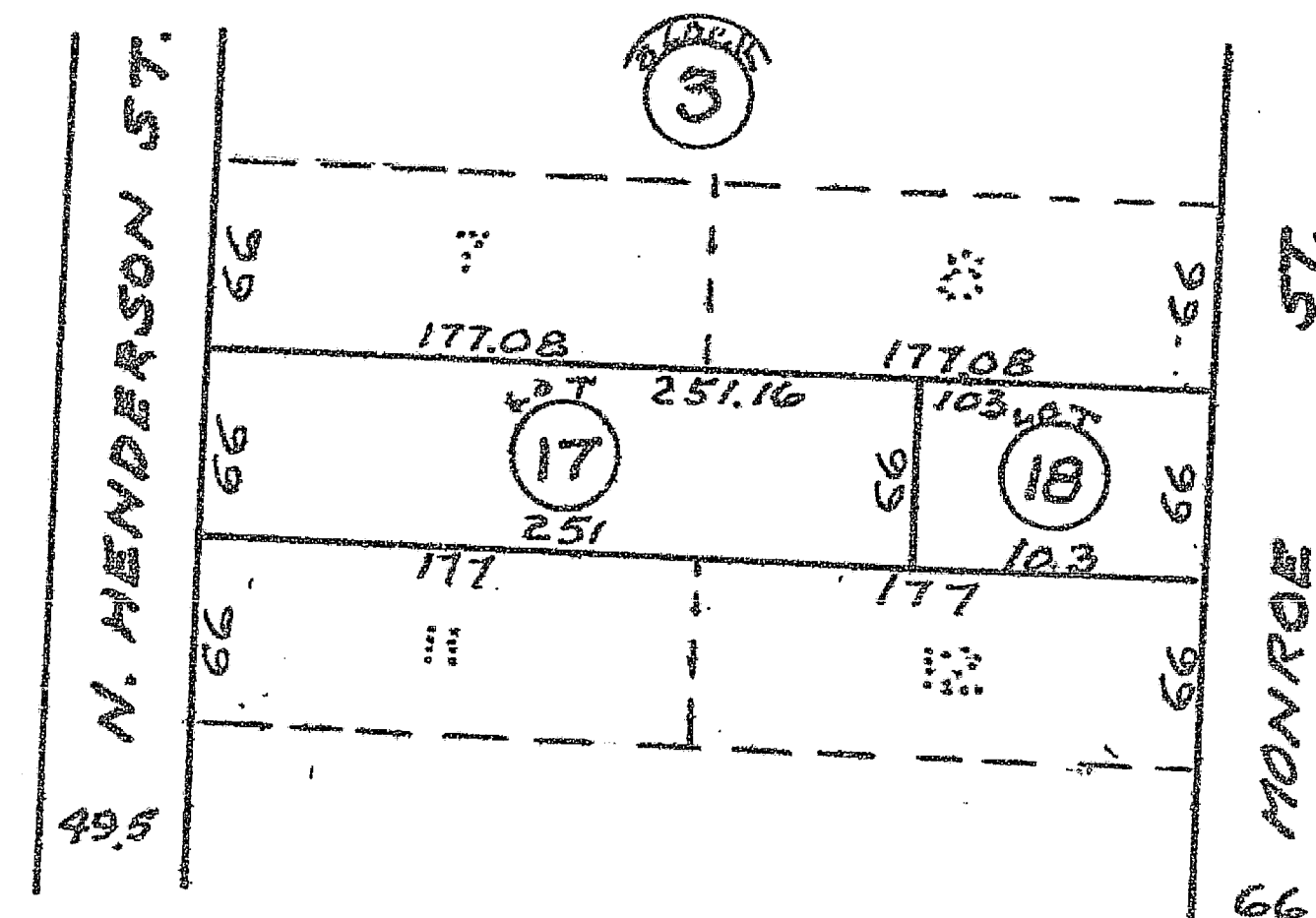

SCALE 1"=120'

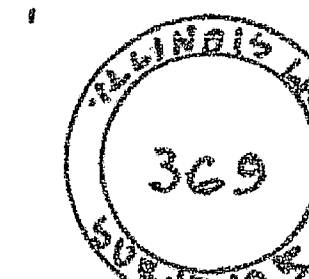
