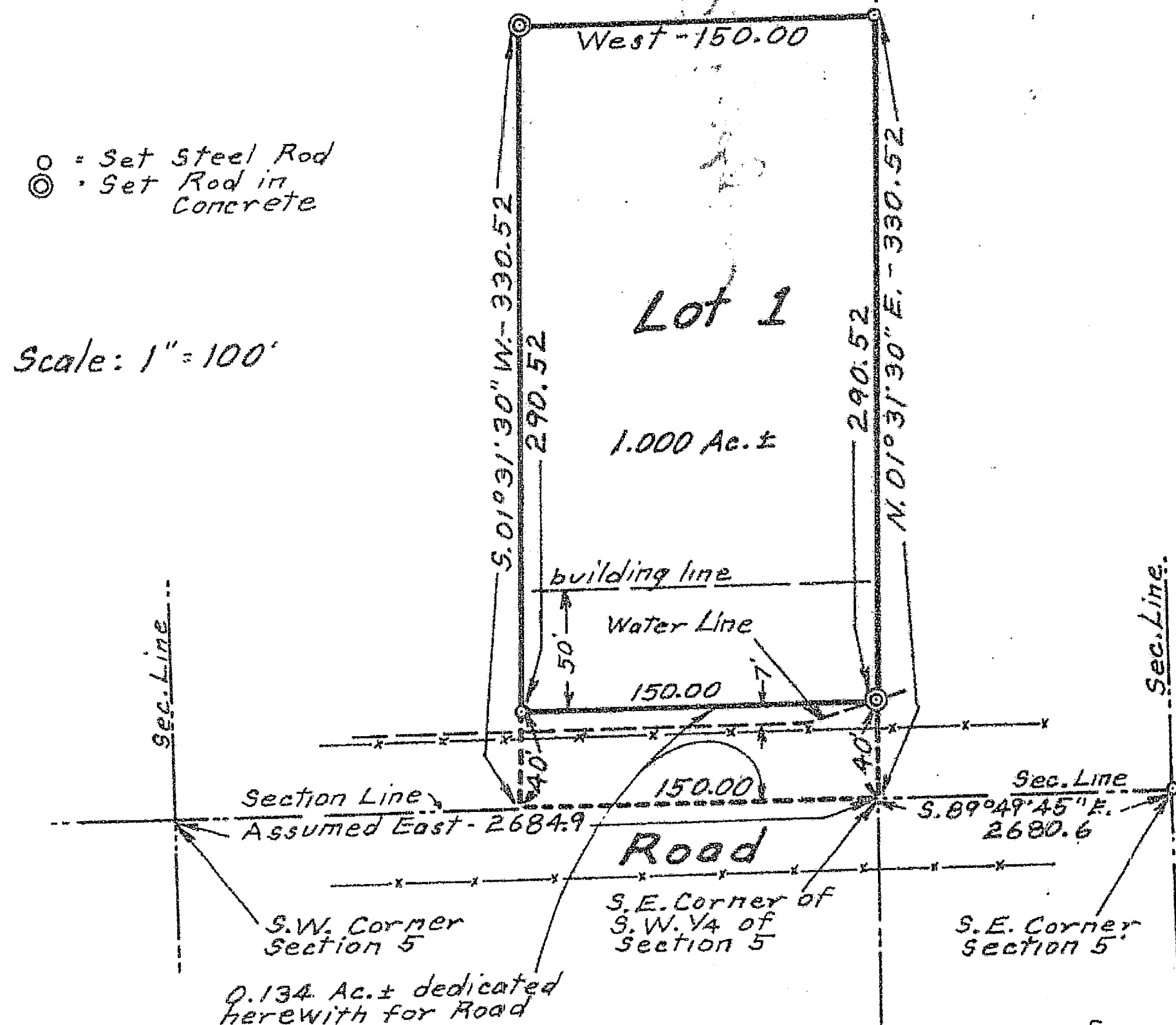
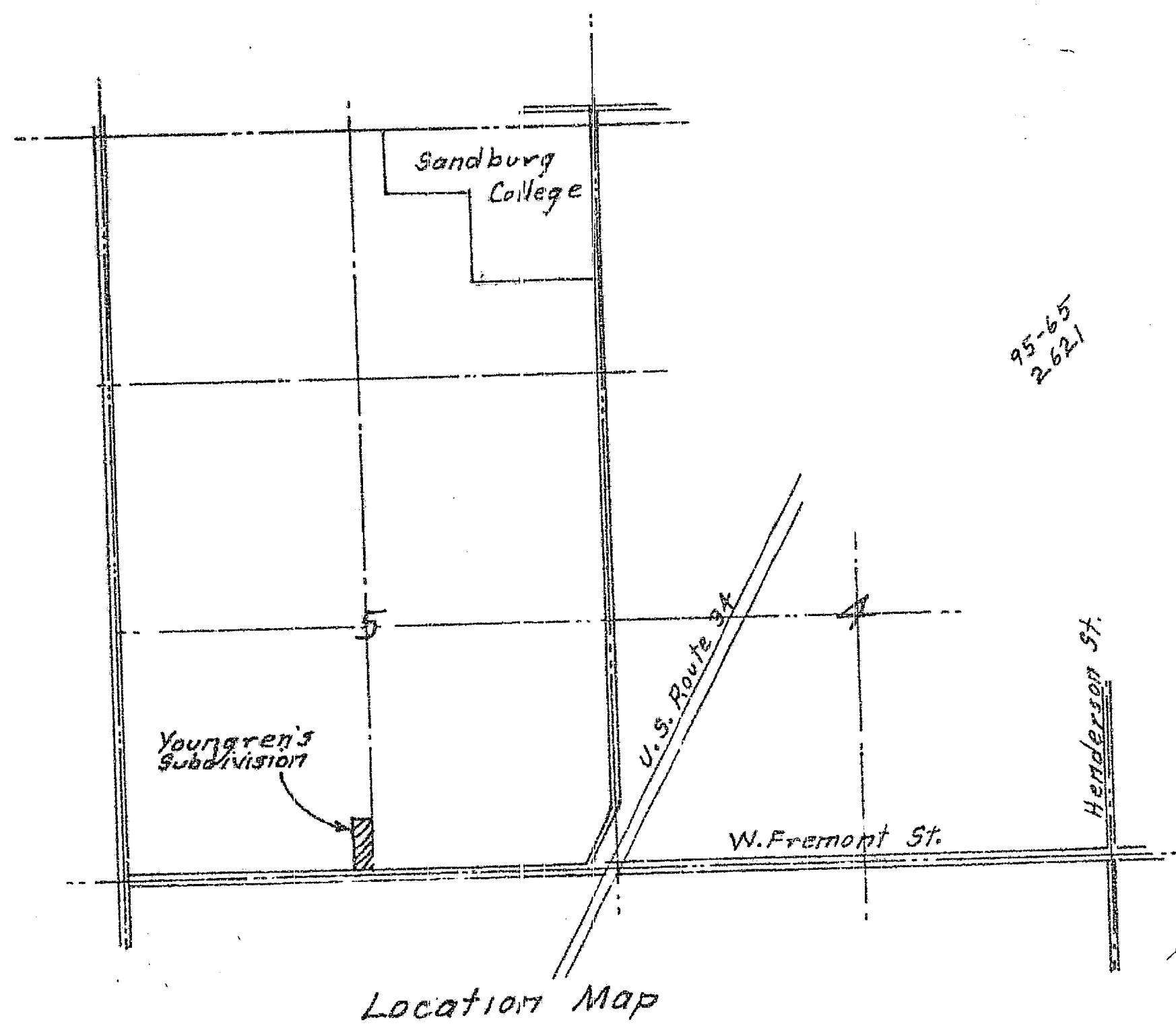


Youngren's Subdivision
