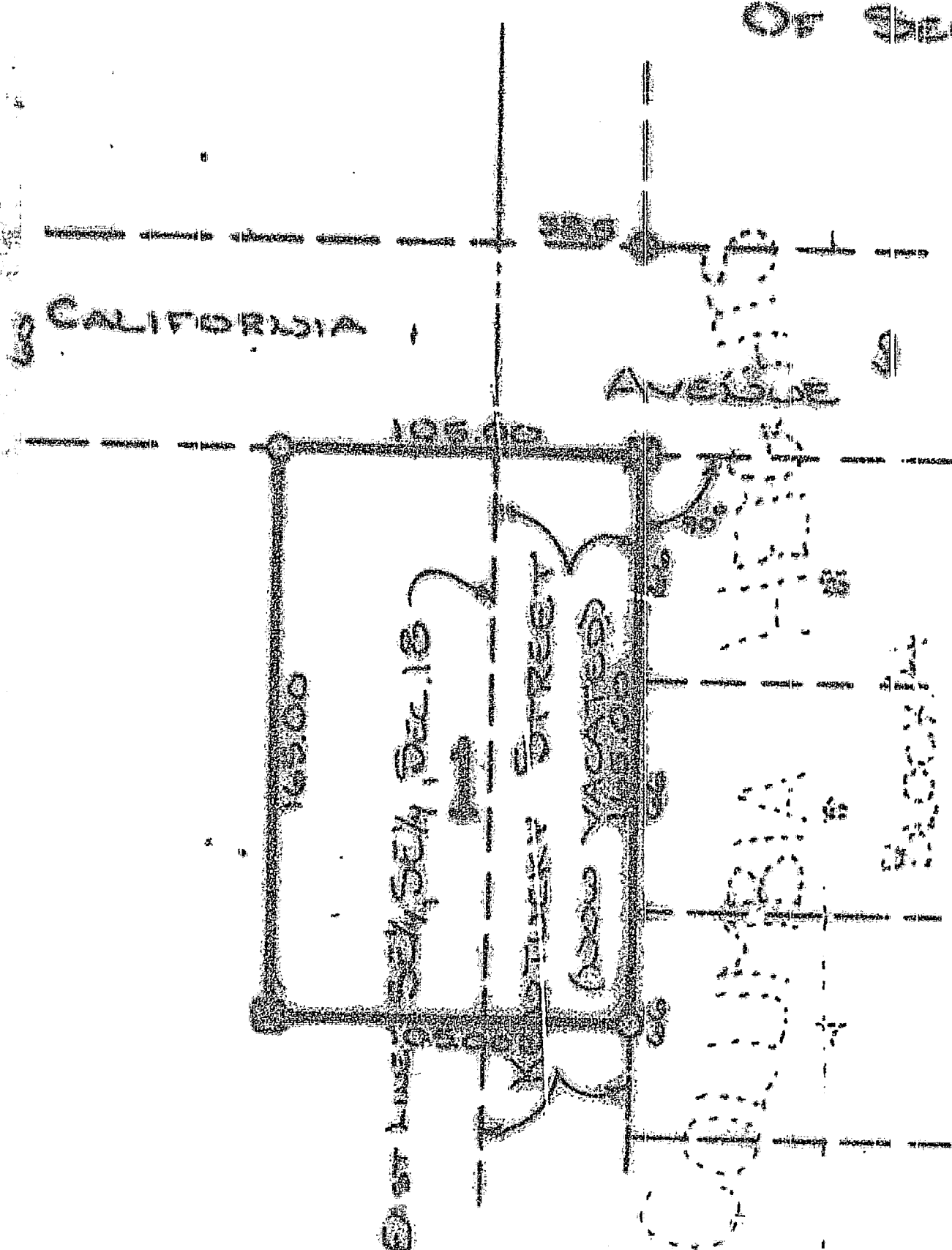


LIFE HOMES ADDITION SECTION ONE
