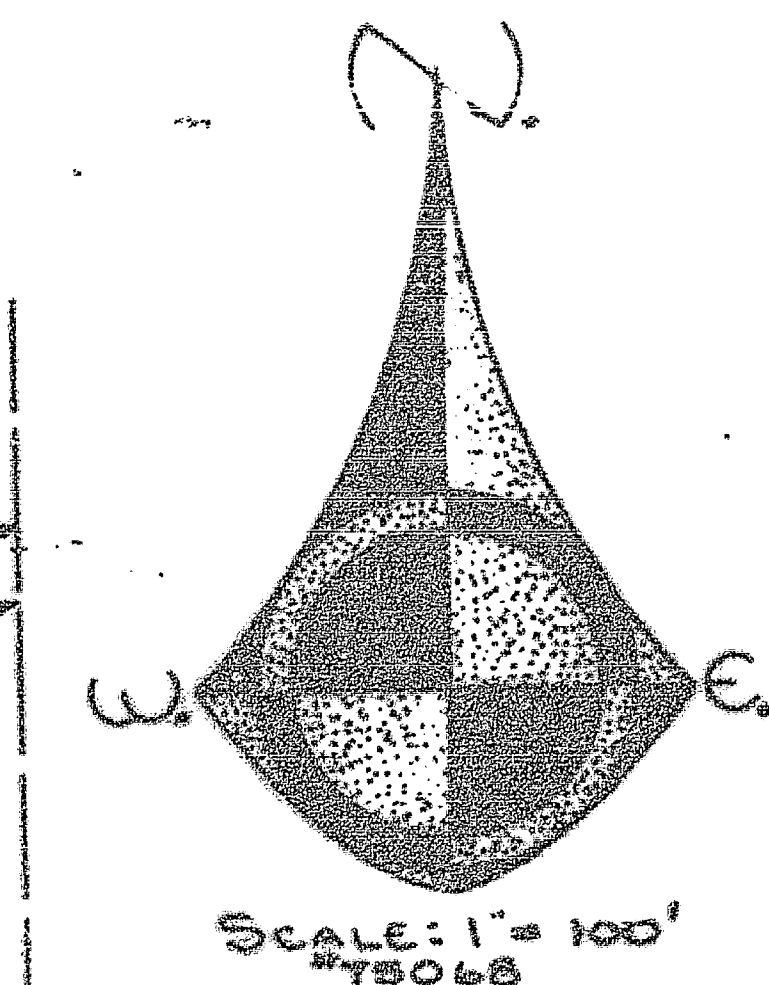
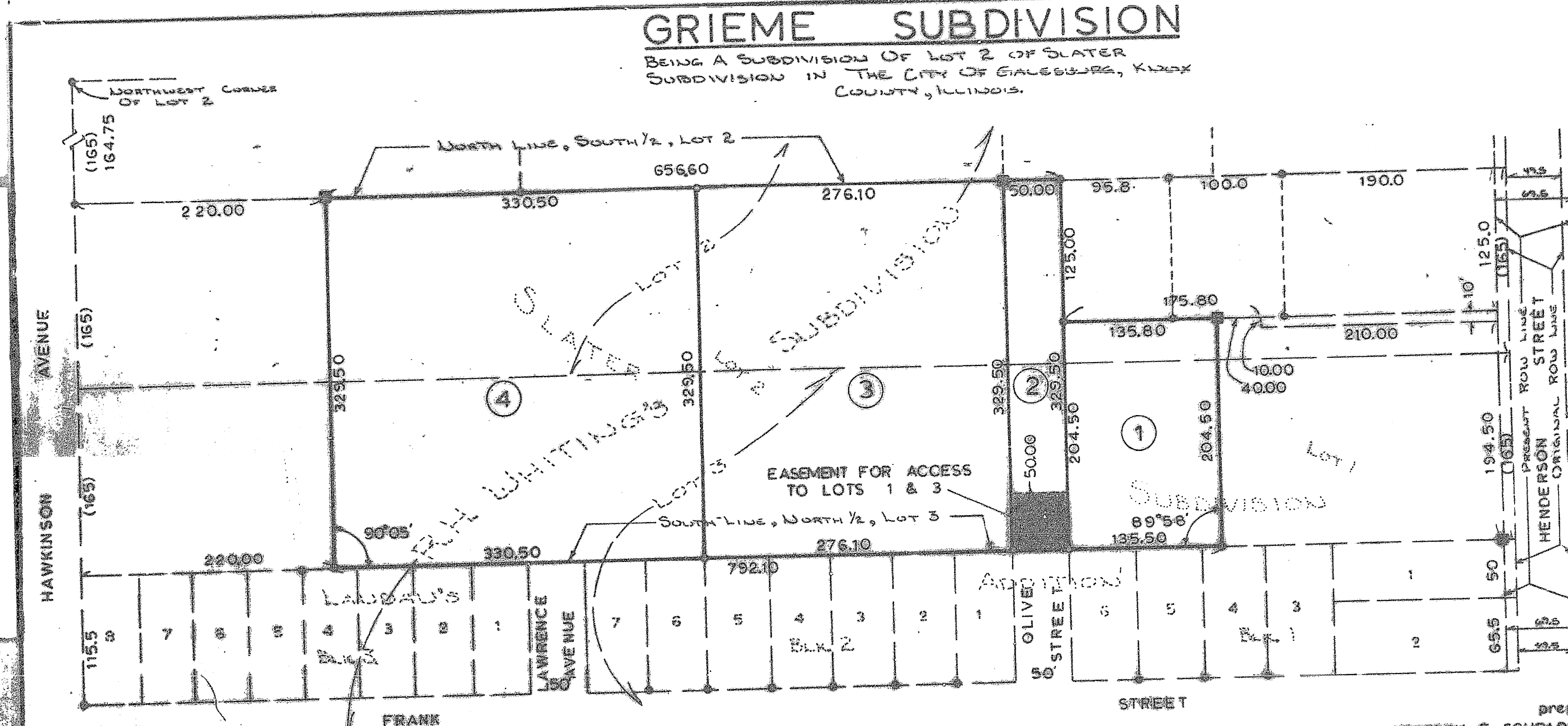


GRIEME SUBDIVISION
