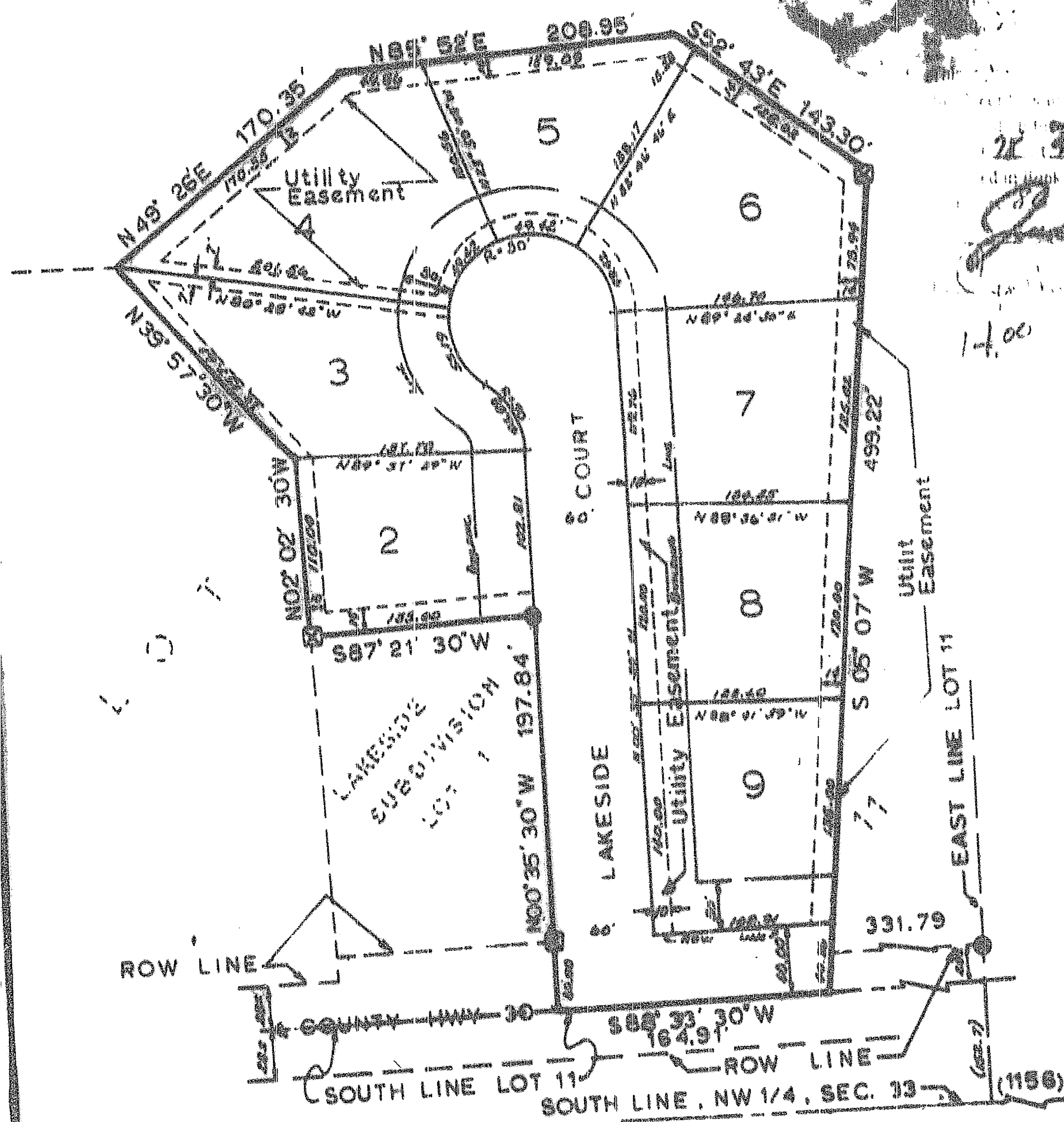


LAKE SIDE SUBDIVISION
