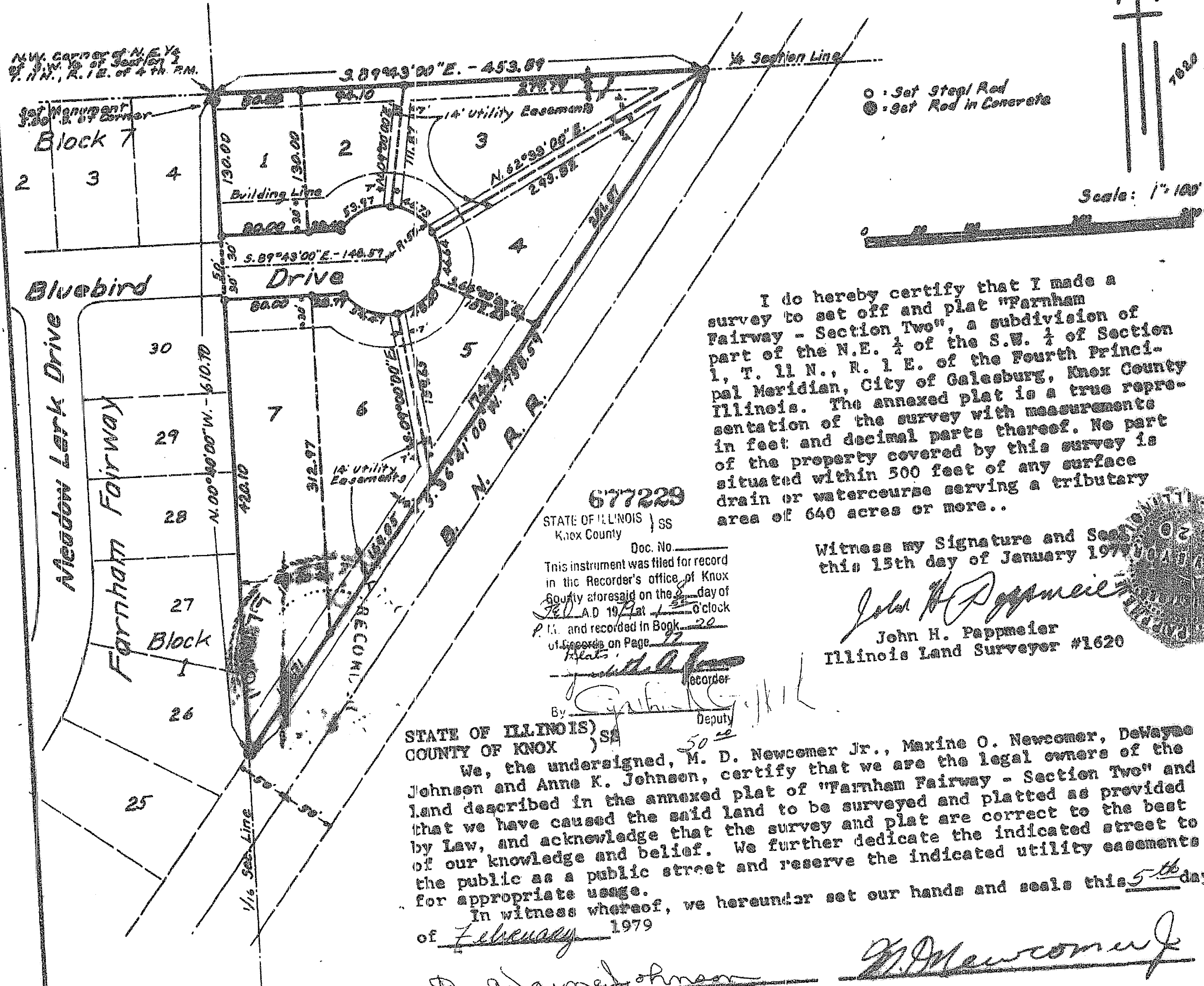


Farnham Fairway - Section Two
