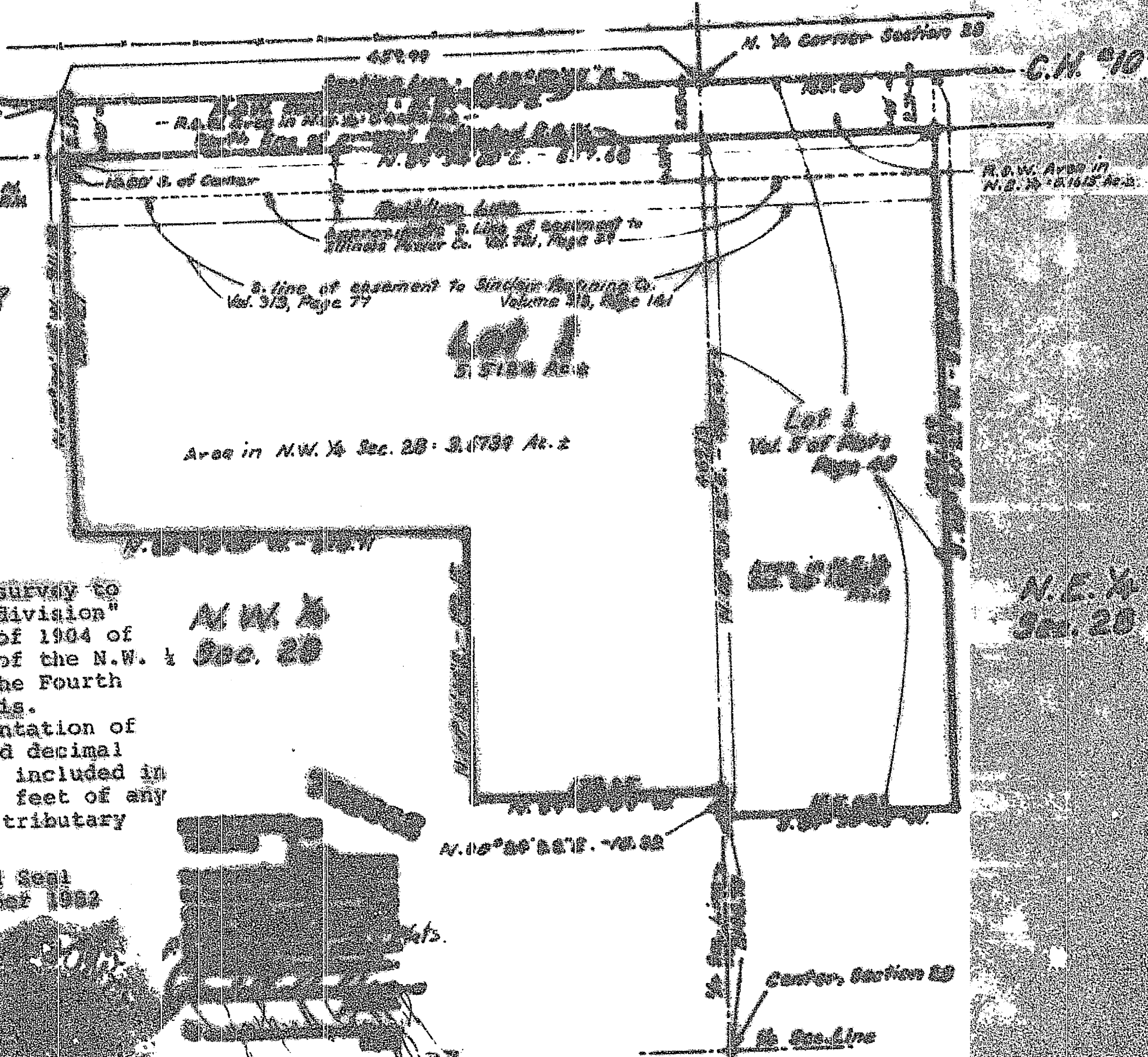
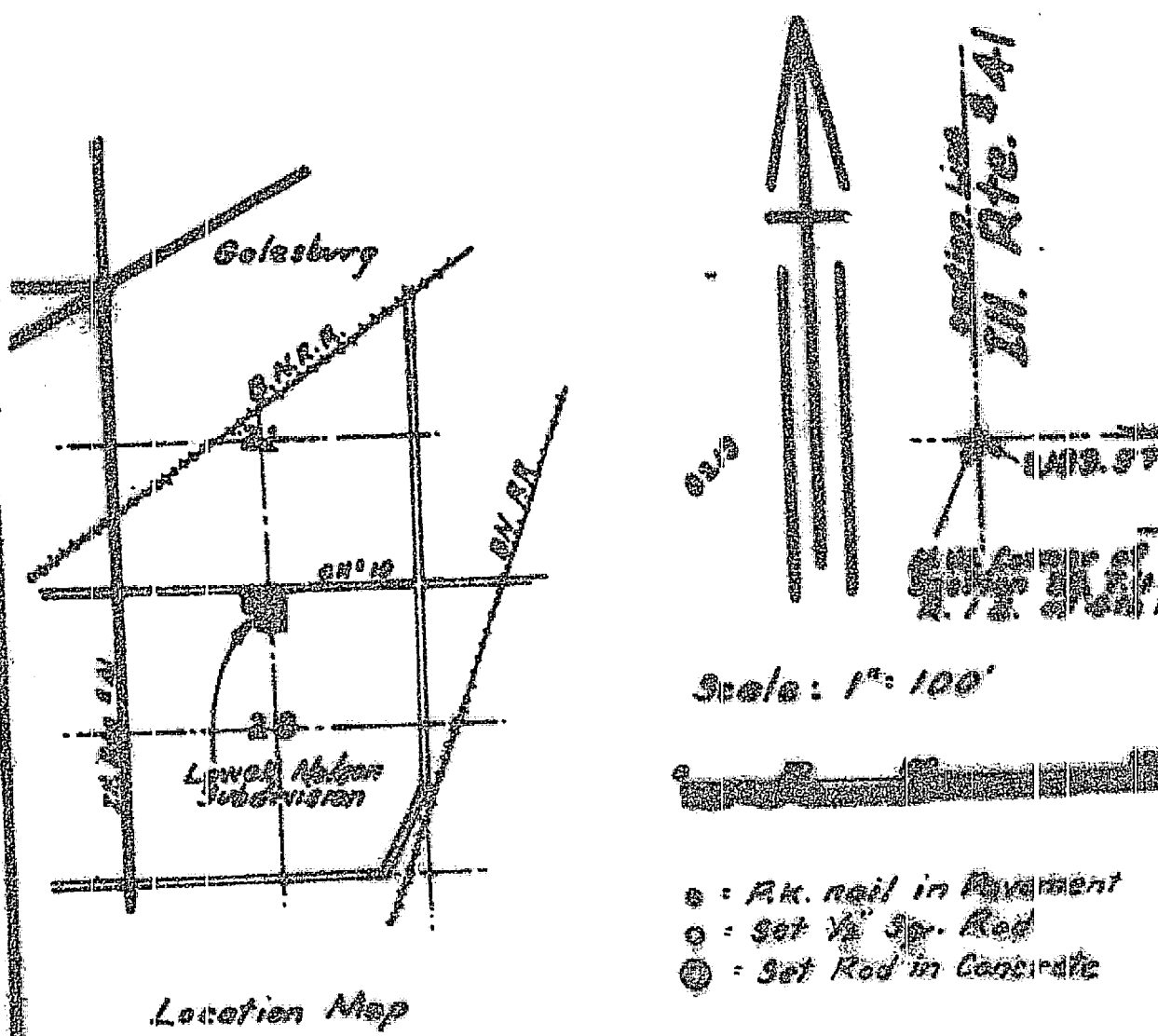


Lowell Nelson Subdivision
