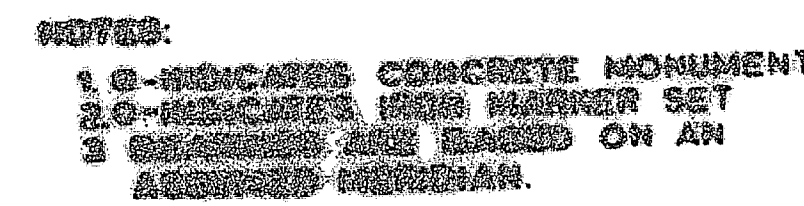


BEING A SUBDIVISION OF PART OF THE WEST HALF OF THE SE 1/4
