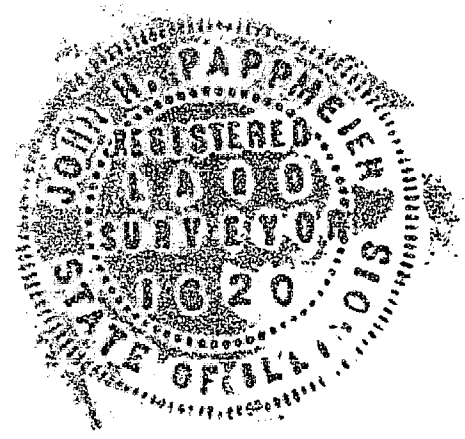


"Michael Gumm Homestead"

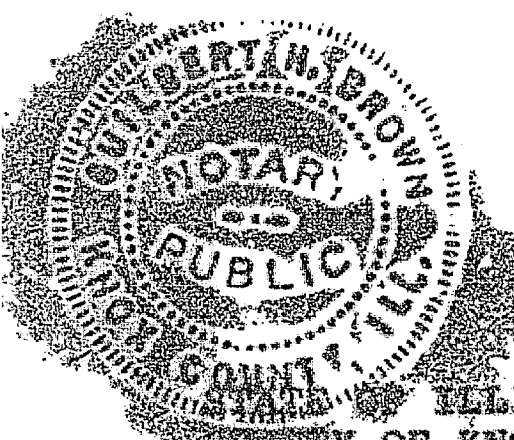
