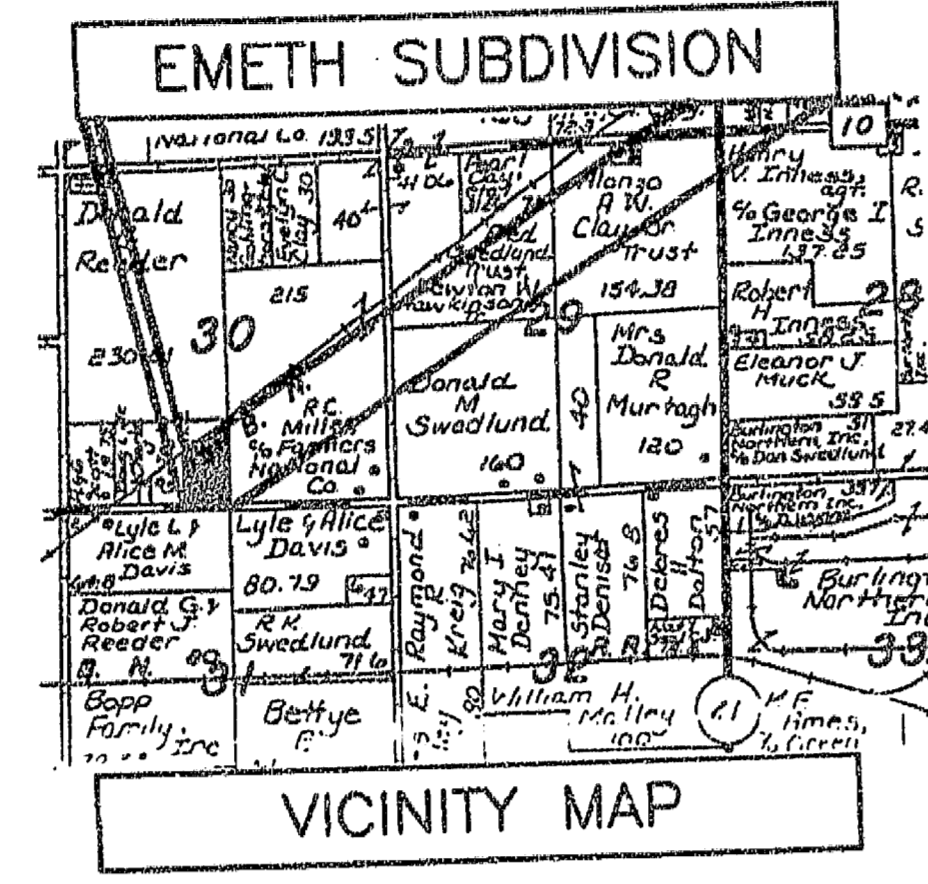


EMETH SUBDIVISION

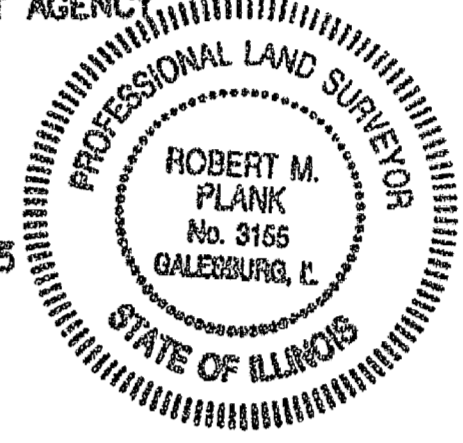
